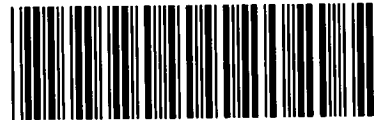

TRUSTEES' REPORT

The Trustees present their report and financial statements for the year ended 31 March 2021 which are also prepared to meet the requirements for a directors' report and accounts for Companies Act purposes.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the charity's governing document, the Charities Act 2011, the Companies Act 2006 and the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

Structure, governance, and management

The charity is a company limited by guarantee and a registered charity. The company was established under a Memorandum of Association, which established the objects and powers of the charitable company and is governed under its Articles of Association. The Memorandum of Association was last updated on 28 January 2021.

The Trustees, who are also the directors for the purpose of company law, and who served during the year were:

None of the Trustees has any beneficial interest in the Company. All of the Trustees are members of the company and guarantee to contribute £1 in the event of a winding up.

The charity's purpose as set out in the object's clause of the company's memorandum of association are to:

- Promote any charitable purpose for the benefit of the community in Bracknell Forest, Berkshire, and the Thames Valley, in particular the advancement of education, the protection of health and the relief of poverty, distress and sickness.
- Promote and organise co-operation in the achievement of this objective and bring together in council representatives of voluntary organisations and statutory authorities within the area of benefit.
- Promote effective community service and activity in Bracknell Forest, Berkshire and the Thames Valley, to strengthen voluntary organisations by offering a range of vital services and to provide opportunities to draw them together within the voluntary sector and to act as a strategic partner with local statutory agencies.

During the reporting year the Trustees reviewed and agreed that the focus of involve should continue with its core functions. The main functions are infrastructure, volunteering, funding, trustee recruitment and training support. This review looks at what has been achieved and the results of involve's work in the previous 12 months. The review helps to ensure our aims and objectives remain focused on involve's stated purpose. We have referred to the guidance contained in the Charity Commission's general guidance on public benefit and the trustees consider how planned activities will contribute to the aims and objectives set.

Governance

All policies and procedures are reviewed either on an annual basis or when it is legally necessary.

The CEO (or nominated individual fulfilling such role as agreed and identified by the Trustees, hereon referred to as the CEO) is responsible for the day to day decisions, including expenditure on items up to £500, with the exception of the Payroll. The Trustees agree Policies and Procedures and any substantial financial decisions affecting the long term aims of the organisation.

New Trustees are normally recruited by the Trustees, although there are arrangements in place for members to nominate a person to be a Trustee. Trustees are appointed by an ordinary resolution of the charity. In identifying potential new trustees, the Trustees are mindful of any identified shortfalls in the skill set of the current Trustees. Appropriate training will be offered to new trustees in the light of their existing skills and experience.

Via the Business Plan, Business Continuity Plan and Policies such as involve's Reserves Policy the Trustees and the CEO have covered risks including financial, physical and operational risks. These are reviewed by the Board of Trustees and systems or procedures are in place to manage these identified risks.

involve is affiliated to the National Association of Voluntary Community Action (NAVCA).

Review of Activities 2020/21

2020/21 proved an extraordinary year, with the challenges of the COVID pandemic impacting individuals and communities locally, nationally, and across the world. Despite the turmoil caused, involve Community Services demonstrated considerable resilience, responding flexibly to the new challenges facing the lives of residents, neighbourhoods, community groups, charities, and social enterprises across Bracknell Forest and Wokingham Borough. Trustees would like to thank all staff and volunteers who responded to need with great compassion and humility. The board recognises the resilience, strength and resolve shown in this respect.

In February 2021, involve's General Manager, Philip Cook, left his post to move to pastures new. The trustees would like to express their sincere gratitude to Phil for the dedication he showed during his 6-years in leadership. The growth of the organisation under his management has been considerable, and the achievements, a solid foundation on which to continue to build.

We were delighted that Deputy General Manager, Philip Bell, stepped into the role of Chief Executive Officer, a post created upon Philip Cook's departure. Philip provides ongoing stability for the charity whilst nurturing new ideas and ambition to support its furtherance. The Trustees would like to extend their thanks to Phil, in stepping into this role and providing continued leadership within the organisation, capitalising on the foundations put in place by Phil Cook, and continuing to enable involve to grow in both services and reputation.

Staff and volunteers at involve Community Services have worked tirelessly to ensure the charities core business is delivered and charitable purposes supported. A big thank you goes to Jackie Eddolls, Finance Manager, for her continued commitment and diligence of the charity's funds. In addition, the Boards thanks go to Clarissa Webb, Administrator and Web Media Support, who works to keep the charity's websites and newsletters, as well as to support reception duties. We also extend our thanks to Tracy Howat for her ongoing administrative and building facilities support.

The Trustees have welcomed: Miranda Millan, Grant Writer; Milly Randall-Davies, Social Prescriber; Matt Wilson, Winter Pressures Navigator and Aimee Knight, the team's new Operations Manager. All those named have settled quickly into the team and are already making significant contributions in their respective areas of delivery.

We have also welcomed and said our goodbyes to Liz Bird, Community Navigator (maternity cover); Dave Fergus, Grant Writer; and Martin Lindup, Database Implementation Lead; who all joined the charity for a fixed term during this financial year. Our thanks are extended to each of them for their contribution.

Our board of Trustees remains strong with eight individuals in these leadership roles, James Harrison remains as Chairperson, Roumie Radountcheva as Treasurer and Malcolm Dudson as Vice Chair.

The Board of Trustees would like to extend their thanks to all organisations who have provided funding to involve Community Services in 2020/21. These include Bracknell Forest Council, Wokingham Borough Council, the Berkshire West Clinical Commissioning Group, Wokingham North Primary Care Network, Get Berkshire Active, Berkshire Community Foundation, CAF Resilience Fund, Shanly Foundation, Boehringer Ingelheim, the Co-op Community Fund, the Card Factory Foundation, and Syngenta.

We are also very grateful to those charities, groups and organisations who have interacted with involve Community Services during the year. Specific thanks go to those who have accessed one of our paid for services. Access to our paid for offers has been primarily achieved through our training provision, through the inTRUSTed Trustee Recruitment and Liaison Service has also generated needed income.

Finally, the Board would like to express its thanks to any partner or stakeholder not formerly covered. We are fortunate to have many existing relationships and are truly grateful for each of them.

Though the account below cannot offer full detail of involve Community Services' achievements in 2020/21, it does give a summary of performance against the charity's 5 key delivery areas.

Training: Source, broker, and providing training for Volunteers and VCFS organisations.	Over 1,000 learners attended an involve training course in 2020/21 with more than 103 courses delivered. Our training is well attended, highly regarded, and is provided by experienced facilitators.
Funding advice: Identify and promote grant funding opportunities and support organisations with applications as required.	<p>The Funding Advisory Service assisted nearly 81 organisations with either bespoke funding searches or critical friending of grant applications. It also sent out weekly funding alert newsletters to over 300 subscribers. The service delivered 9 related teaching sessions and helped to create funding applications to the value of £1.2 million.</p> <p>In addition to the general Funding Advisory Service, involve was fortunate to secure additional finance in year from Bracknell Forest and Wokingham Borough Council to provide a free grant writing service to the local Voluntary and Community Sector. This has helped to combat the significant financial impact of COVID on local community groups, registered charities, and social enterprises. The Grant Writing service has drafted grants to the value of £1.7 million, and to date has successfully brought in £180k across the 2 boroughs with a significant volume of applications awaiting an outcome.</p>
Information: Provide new and existing VCFS organisations with constitutional, management, administrative and developmental	Over 160 offers of support, governance advice, start-up assistance and networking have been provided to local charities and community groups over the last year. Areas of focus have included good governance, organisational development, policy creation, leadership advice and more.

Trustee Recruitment and Liaison: Recruiting, preparing and matching skilled individuals to trustee vacancies whilst offering ongoing support and training to ensure clarity of role and responsibility.	Our inTRUSTed Recruitment and Liaison Service has successfully placed 20 trustees into local charities, as well as generating a bank of potential trustees for the future. In addition, 7 training courses have been delivered to over 60 learners, all of whom have either been newly appointed to their respective board, or who want to refresh their learning regarding trustee roles and responsibilities.
Volunteer recruitment: Including Business in the Community, building opportunity through the 'get involved' volunteer portal, and supporting those who require additional assistance to volunteer.	Bracknell Forest only – The online volunteer centre – 'Bracknell Forest Get Involved' showcased an average of between 120-140 live volunteering opportunities. 230 volunteers submitted expressions of interest directly to the office, The online volunteer centre had over 5,500 new visitors in the year. 1,200 plus of the sessions on our website lead to people clicking on links to find out more about an opportunity or to make contact (with 22% of these directly contacting the organisation, approximately 265 email/calls). We also saw a decrease in business volunteering, with involve enabling 30 corporate volunteering days. A total of 48 people volunteered through their place of employment. Covid volunteering 500 applications, 150 active volunteers.

In addition to its 5 core areas of delivery, involve Community Services also brings attention to its other areas of delivery:

Covid Community Response

In this extraordinary year, involve Community Services worked in partnership with the Ark Trust and Bracknell Forest Council to build and deliver a community response that supported residents most vulnerable to the impact of Covid-19. Together, we worked to recruit an army of volunteers, then matching these supporters to those residents who required help to access food supplies, prescription medication and other essential supplies. In addition, a bank of involve volunteers extended the hand of friendship through telephone befriending.

Within Wokingham Borough, involve Community Services supported the creation of a collective voluntary and community sector offer in which several organisations undertook assigned roles in accordance with their charitable purpose. Recognition should also go to the many community covid groups that set themselves up so to support their neighbourhoods across both boroughs.

In addition to the above, staff undertook a substantial number of welfare calls to vulnerable residents within Bracknell Forest and Wokingham Borough, coordinating with fellow partner agencies as appropriate. Overwhelmingly, recipients of these calls expressed gratitude for the time and care shown.

involve Community Services was fortunate to receive additional funding for its Covid-19 work from the Berkshire Community Foundation, the CAF Resilience Fund, Shanly Foundation, and Wokingham and Bracknell Forest Councils.

Cancer Support Network

The Cancer Support Network moved from its second and third year of delivery in the Autumn of 2020. Towards the end of the financial year the network secured funding from the Wokingham Better Care Fund and the East

Berkshire Clinical Commissioning Group to continue providing support into 2021/22 to residents of Wokingham Borough whilst also growing the network into the East of Berkshire.

During the year, the Cancer Support Network supported nearly 80 residents affected by cancer with the demand growing steadily. The service enabled opportunity for users to access online wellbeing activity as well as peer support sessions, and a managed WhatsApp group, physical events and cancer champion volunteers who are suitably trained to listen and support a member throughout their cancer journey.

Y referred by Macmillan into the Cancer Support Network in July 2020. Following a diagnosis of bowel cancer, he was very anxious and distressed about his diagnosis and treatment. The network was able to connect him to another member who was able to talk to him about the treatment and some of the side-effects that he might experience. The network sent him resources that could help him on his cancer journey and with his wider wellbeing. Y was also able to access 1-1 ongoing support through the cancer champion volunteer programme. The network extended a hand of friendship, with Y engaging in several social activities with others who understood. In his own words: "The network has supported me throughout my journey. I do value the support that you provide enormously - thank you."

Supported Volunteering Scheme

Supported Volunteering has seen less demand in 2020/21 due to Covid-19 restrictions. Despite this, the service has responded to the 23 referrals made and has worked to find opportunity wherever it has been able.

Community Navigator Scheme

Community Navigation adapted well to the changing landscape of need caused by the pandemic. The volume of calls for signposting initially reduced heavily as the country moved into lockdown. At this point, the team stepped in to aid the Wokingham GP surgeries and other health and social care partners to undertake welfare calls to those most vulnerable with more than 100 contacts made. Through the summer, the scheme began to return to its core work, with a steady number of residents navigated to services and groups that could support them. In total 310 local people were assisted.

Mrs X was living in a Wokingham Borough Council care home and needed her bed removed and replaced with a medical bed. Community Navigation were contacted by her Social Worker. There is no service for this and due to COVID rules this was exceptionally difficult to arrange. Community Navigators managed to source two volunteers from a local (to service user) Community Support group who offered to carry out the removal of the bed in a timely manner, due to medical bed being delivered. The client and social worker were very grateful and appreciative of our efforts.

Volunteering Pool

involve Community Services understands that not all who would like to volunteer can do this routinely. We have grown our membership from 121 volunteers as at 1st April 2020 to 227 for this purpose as at 31st March 2021. As requests are made for bespoke support, members of our volunteer pool are notified and those available to assist respond. In 2020/21, 67 opportunities to the volunteering pool were offered.

Winter Pressures

involve Community Services was commissioned to deliver a Wokingham Borough Winter Pressures Navigation Scheme for a third consecutive year in 2020/21. A new employee was brought onboard to deliver this work, supporting and aiding residents to keep safe over the colder months. 25 residents were engaged throughout the season. Whilst there was less face to face work than in previous years due to Covid-19 restrictions, the regularity of telephone contact and prompt response to need received very positive feedback from the service users.

'Mrs X was referred by Adult Social Care feeling isolated, lonely and in need of support to maintain her independence at home. She was referred to a local befriending scheme to establish positive social contact, and after experiencing a particularly difficult period of isolation, collaboration led to the frequency of this support being increased. Mrs X was also referred and supported to access a service providing domestic

assistance, supporting her with tasks around the home that she was no longer able to manage independently. This service was able to provide continuity and a level of companionship, further reducing feelings of isolation.'

Community Resilience

involve Community Services has worked to support community resilience across both boroughs, bringing attention to key matters such as hate crime, exploitation, knife violence, bullying and more. Working in partnership with statutory partners, involve Community Services has formulated messages and developed campaigns, providing the public with accurate information and support services contacts where applicable. An exploitation prevention conference had been planned for the end of March 2020 but was subsequently cancelled due to covid. A smaller virtual event was then delivered in November with over 60 people attending, and very positive feedback subsequently received.

Social Prescribing

involve Community Services secured further funding from the Wokingham North Primary Care Network to expand the delivery of a social prescribing service in the north of the Wokingham borough, with a second full time worker recruited during the summer. Social Prescribers have made a huge impact to patient outcomes in the North PCN, with non-medical interventions offered to 275 patients in this financial year.

X is a man in his twenties living with autism and anxiety. The social prescribing service worked with X over a six-month period, meeting up face to face every fortnight to provide space to talk and to develop strategies that could assist him to best process his worries and develop aspiration for the future. X enjoyed speaking to someone outside of the medical profession and his family and continues to work towards independence.

Future Leaders

involve Community Services was delighted to finally launch the Future Leaders management course working with Alan Hester Associates. The course has been linked to the government Apprenticeship Scheme so to create an accessible, affordable offer for aspiring leaders in the charity sector. Ten learners are part of this pilot training programme.

VCS Emergencies Partnership Fund

Via the NAVCA network, involve received a small package of funding to work closely with other Council for Voluntary Service (CVS) organisations. The purpose of this collaboration has been to better understand the true impact of the pandemic upon our communities and across the Voluntary, Community and Faith Sector.

Friendship Alliance

The Friendship Alliance is a collaborative of 4 charities, The Link Visiting Scheme, The Wokingham Volunteer Centre, Age UK Berkshire and involve Community Services. The alliance's core purpose is to promote friendship, tackling isolation and loneliness across Wokingham Borough. Despite the challenges of the pandemic, the project has made significant progress in meeting its core objective, keeping residents connected during periods of lockdown. A small amount of funding comes to involve contributing to its Community Navigation scheme who continue to lead on reporting on the outcomes of the Friendship Alliance work.

Funding/Financial Review

involve Community Services continues to deliver its infrastructure support within the communities of Bracknell Forest and Wokingham Borough. The core services grant provided by Bracknell Forest Council remained unchanged at £126,900 (2019/20: £126,900), and in Wokingham Borough, £84,100 (2019/20: £88,500), £72,100 from the local authority and a further £12,000 from the Berkshire West Clinical Commissioning Group. These ongoing funds are a testament to the continuing and strengthening relationship between involve Community Services and the funders with which it works.

All funds transferred to involve from the Trustees of the Victoria Hall Fund ("VHF") have now been allocated and spent. Income for restricted funds and projects rose again in 2020/21 to £180,975 (2019/20: £164,775), reflecting involve's Community Services broader and more varied reach. The Trustees' policy is to diversify the income base and consider additional projects/opportunities that align with the organisational objectives. Income from other sources principally space sharing, training, management fees and other income generation such as through the Trustee recruitment service decreased slightly to £74,796 from £78,124 (2019/20).

Support costs increased to £293,916, (2019/20: £233,945). Governance costs included therein were *stable* at £12,885 (2019/20: £10,915). Hours worked increased by 37% (2019/20: increased by 7%) compared with the previous period, and is reflective of the growth in some of our service areas.

Unrestricted reserves increased in the year, by £10,976 to £212,262 (2019/20 £201,286). involve remains in a solid financial position and thanks to the strong relationships it continues to foster with core funders, the trustees maintain cautious optimism. (Note: Unrestricted reserves are linked to the 2 core work area income streams in Bracknell Forest and Wokingham Borough).

It is involve Community Services' policy to maintain reserves to the value of at least 5 months' core expenditure. This would allow time to plan a suitable response in the event that funding is reduced, and would allow the charity to wind down its services and to cover its costs effectively should there ever be need into the future.

The Cash Balance of £300,232 (2019/20: £250,266) is sufficient to cover our outstanding restricted fund commitments.

The trustees are of the view that the charity is a going concern.

Future Plans

2020/21 has been successful for involve, and the changes to the team's composition have now been firmly embedded and are paying dividends. The priority for the charity moving forward is to ensure its relevance, sustainability, network & reach, and quality. Integral to this is staying true to the core purpose of the charity, supporting other charities, community groups, and communities, and making a difference locally.

In the year ahead, we will look to maximise our service delivery. Respond sensitively and in a timely fashion to the needs of our communities and the sector, whilst nurturing new opportunity, informed by involves charitable purpose.

Asset cover for funds

Note 13 sets out an analysis of the assets attributable to the various funds and a description of the trusts. These assets are sufficient to meet the charity's obligations on a fund by fund basis.

Risk

The organisation is supported by a few local organisations (primarily Bracknell Forest Council, Wokingham Borough Council and Berkshire West CCG) in the form of grant income receivable. This grant income is fundamental to the continuation of involve and as such, the potential loss of this income has been identified as one of our primary risks. The risks identified, associated with our core grant income/primary funders are *medium* in the short term. While a complete loss of grant is unlikely, given the challenging outlook for local authority funding in the near term a reduction in grant levels is something that involve should be prepared for. This risk is mitigated by mindful husbandry of the organisation's reputation.

In addition to the risk highlighted above regarding loss of funding from a primary funder, there is also the risk of expenditure being in excess of budget because of unforeseen circumstances. This is monitored by the Trustees and CEO regularly so that, where possible, steps can be taken to mitigate the impact of this.

Statement of Trustees' responsibilities

The trustees (who are also the directors of Involve Community Services for the purposes of company law) are responsible for preparing the Trustees' Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the trustees to prepare financial statements for each financial year. Under company law the trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources, including the income and expenditure, of the charitable company for that year.

The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the accounts comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

This report has been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) and in accordance with the special provisions of the small companies regime (Section 419(2) of the Companies Act 2006).



1 Accounting policies

1.1 Basis of preparation

The accounts have been prepared under the historical cost convention.

The accounts have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) and the Companies Act 2006.

involve Community Services meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

The financial statements are prepared in sterling, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest £.

1.2 Going Concern

In their assessment of going concern the trustees have considered the current and developing impact on the charity as a result of the COVID19 virus. The Covid-19 pandemic has had some impact on the charity's operations but generally services have continued. The trustees are aware that if the current situation becomes prolonged further adaptations may have to be considered. Whilst there remains uncertainty regarding the duration, extent and ultimate impact of the pandemic, the trustees cannot estimate with any precision the impact on the financial performance of the charity. In particular, any changes in regulations introduced, as a result of the economic impact of the Covid-19 pandemic, that may have an impact on the services we offer.

A proportion of our people are working remotely in accordance with our risk assessment planning, and this remains a viable scenario. The resilience and adaptability of our people, coupled with the use of existing and embracement of new technologies, has meant that the charity has been able to continue to provide a high level of service to its service users. It is expected that this will continue as appropriate measures are implemented, in line with recommendations and guidance, to allow the continued use of our offices and the return to face-to-face meetings and services.

The charity has considered forecasts which take account of expected changes in the charity's income and expenditure and this demonstrates that the charity will be able to operate within its current level of facilities. Various scenarios relating to the ongoing Covid-19 pandemic show that the trustees expect the charity to have adequate liquidity to meet its obligations as they fall due. On this basis, the trustees consider it appropriate to prepare the financial statements on the going concern basis.

1.3 Income

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the items of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Income from grants is recognised when the charity has entitlement to the funds, any performance conditions attached to the items of income have been met, it is probable that the income will be received and the amount can be measured reliably and is not deferred. Donations and legacies and other forms of voluntary income are recognised as Income when their receipt is probable and the amount can be measured reliably.

1.4 Expenditure on charitable activities

Liabilities and related expenditure are recognised once there is a legal or constructive obligation to make a payment to a third party, it is probable that settlement will be required and the amount of the obligation can be measured reliably.

Expenditure falling directly within one activity is allocated only to that activity. Central costs have been apportioned and allocated between support costs and governance costs of the charity on the basis of time spent on each activity. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

1.5 Allocation of support costs

Support costs are those functions that assist the work of the charity but do not directly undertake charitable activities. Support costs include back office costs, finance, personnel, payroll and governance costs which support the charity artistic programmes and activities. These costs have been allocated between cost of raising funds and expenditure on charitable activities. The bases on which support costs have been allocated are set out in note 6.

1.6 Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Assets of value of less than £500 are not capitalised. Depreciation is provided at rates calculated to write off the cost less estimated residual value of each asset over its expected useful life, as follows:

Equipment	33% straight line
Office equipment	33% straight line

1.7 Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

1.8 Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

1.9 Financial instruments

The trust only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.

1.10 Pensions

The charity's contribution to employee personal pension plans are charged on a monthly basis within salaries.

1.11 Accumulated funds

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the accounts.

1.12 Legal status of the charity

The charity is a company limited by guarantee incorporated in England and Wales and has no share capital. In the event of the charity being wound up, the liability in respect of the guarantee is limited to £1 per member of the charity.
