- Key achievements for 2019-20:
 - Training Over 1000 places were taken on our many different training courses
 - Funding nearly 100 organisations supported/advised re: funding/fundraising and over £460k worth of funding bids supported directly by involve
 - Info/support over 400 organisations were supported with advice, information, governance, policies and more
 - Trustees 14 trained trustees specially recruited and placed in local charities + 5 Trustees training courses delivered with 45 attendees.
 - Volunteers over 200 local volunteering opportunities advertised on the volunteering portal. Online /volunteer centre had nearly 5000 visitors

General Managers Report

- Philip Cook (PC) gave an update and overview of the year passed and where the organisation is now and where it is moving forward.
- **Befriending** Decision was made to close the project in 2019/20. A new provider engaged to set up a scheme in Bracknell Forest to ensure continuous support to vulnerable people and is still very active in the borough
- **Cancer Champions** This project continues to grow. The future will be that the scheme, incubated by Involve, will become its own entity/organisation in the future
- **Volunteer Passport Scheme** This scheme is evolving into a Volunteer pool/network, providing more accessible opportunities. The future model will entail opportunities for businesses alongside community volunteering organisations.

- Winter Pressures This is the second pilot year, expanding Community Navigation to support winter pressures in Wokingham Borough. The pilot nearly 30 people safe, secure and improved their circumstances over the winter period. This additional support enabled people to stay out of the system.
- Community Resilience Not duplicating what other organisations do but identifying the gaps. Recognising there is limited local/national charities, challenging and raising awareness of key social issues such as: knife crime, CSE, hate crime and exploitation. Involve is marketing resources to raise awareness of these pertinent issues locally. Social issues in BFC & WBC do not receive the same level of attention as neighbouring areas.
- **Social Prescribing –** This was started in November 2019. Wokingham North PCN chose to partner with Involve to set up and deliver their Social Prescribing service.
- Future Leaders A training course for Future Leaders in the Charity & Community Sector. The course will be set up and delivered in 2020/21, Currently Twelve people have signed up for a year's long course.
- **Berkshire Sculpture Park** Local gap a virtual guide to public art across Berkshire has begun being established The hope is to secure additional funding to finish and launch this too/resource and maybe find an organisation to adopt and maintain it going forward.

Financial Report

- Roumie Radountcheva, Treasurer, gave an update on Involves finances
- Summary:
 - We have 2 income streams in the accounts: unrestricted, which is recurring for the core activities, and restricted, which is non-recurring.
 - Our main core grants from the two local authorities, Wokingham Borough Council and Bracknell Forest Council the funds received remain unchanged, which was as expected.
 - Higher expenses due to increase in hours.
 - Finances are maintained to a high standard which is thanks to Jackie Eddolls

- 1. Alteration to the constitution to consider and vote upon the following resolution. Within the Articles of Association
- Article 38 (now 39): A trustee shall cease to hold office if he/she/they:

 -removing: Becomes incapable by reason of mental disorder, illness or injury of managing and administering his own affairs and replacing with: in the written opinion, given to the company, of a registered medical practitioner treating that person, has become physically or mentally incapable of acting as a trustee and may remain so for more than three months;
 - Article 45 (now 46) updating: The trustees may appoint one of their number to be the chairman of their meetings and may at any time remove him from that office. Unless he is unwilling to do so, the trustee so appointed shall preside at every meeting of trustees at which he is present. But if there is no trustee holding that office, or if the trustee holding it is unwilling to preside or is not present within five minutes after the time appointed for the meeting, the trustees present may appoint one of their number to be chairman of the meeting.

 Replacing with: The trustees shall make appointments from within their number to the roles of chair, vice chair and treasurer. They mealso make other appointments as they may decide. A brief description of these roles is: {then follows a short summary of each of the

positions)

- Article 51 (now 52) updating: The trustees shall keep minutes in books kept for the purpose:. Replacing with: The trustees shall keep minutes kept for the purpose
- Article 53 (now 54 & 55) updating: Accounts shall be prepared in accordance with the provisions of Part VII of the Act Replacing with:

54. The trustees must prepare for each financial year accounts as required by the Companies Act. The accounts must be prepared to show a true and fair view and follow accounting standards issued or adopted by the Accounting Standards Board or its successors and adhere to the recommendations of applicable Statements of Recommended Practice. 55. The trustees must keep accounting records as required by the Companies Act
