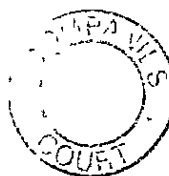

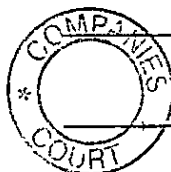

- 9 The office holders appointed under paragraph 1-4 above shall arrange for any Creditor's Committees or Liquidation Committees affected by their appointment to be given notice of this Order in writing as soon as economically practicable, and in any event, within six month's of the date of this Order



- 10 The provisions of Rules 2.47(3A), 6.74A(4), 4.49B(5) and 4.49C-CVL(3)(a) of the Insolvency Rules 1986 do not apply in this case. The period for the provision of progress reports remains the same as the original date in place prior to this block transfer having effect.
