The company was incorporated on 17th April 1997 as GAC No 82 Limited. On 30th April 1997, the company's name changed to Argentium Research Limited

Statement of directors' responsibilities

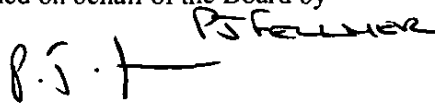

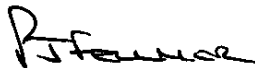
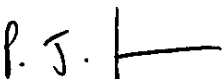
