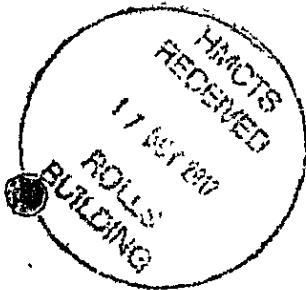

COMPANIES HOUSE

IT IS ORDERED THAT:

1. The Applicant has leave to make a composite application in respect of the insolvency proceedings ("the Proceedings") identified in the schedule attached to this Order ("the Schedule").
2. Any of the proceedings listed in the Schedule which are pending in a County Court be transferred to the High Court solely for the purpose of this Application, and the Applicant do ensure that a sealed copy of every order transferring any case to this Court and of every order which may be made as a result of this application be lodged with the court having jurisdiction over each case affected by such order for filing on the court file relating to that case
3. The Applicant do procure that a sealed copy of this Order is lodged at any District Registry where a case listed in the Schedule is pending.
4. The First Respondent be removed from office as Administrator, Liquidator, Supervisor or Trustee in Bankruptcy (as the case may be) in respect of each of the matters listed in the Schedule hereto in which he held such office.
5. The Applicant be appointed as the Administrator, Liquidator, Supervisor or Trustee in Bankruptcy whether solely or jointly with the Second Respondent (as the case may be) in respect of each of the matters listed in the Schedule hereto in place of the First Respondent, and in each case with immediate effect
6. The Applicant shall within 28 days of the making of this Order, either by letter or by advertisement in the Gazette, inform the creditors of the Insolvencies and the Registrar of Companies:
  - (i) Of the effect of this Order.
  - (ii) Of the liberty to apply contained in paragraph 9 below.
  - (iii) That where Liquidation or Creditors' committees have been appointed to the extent that any information which otherwise ought to be provided under Insolvency Rule



4 108(3) or Rule 6.126(2) (or otherwise) has not already been provided it is open to that committee to require the Respondents to provide an account of their administration of such insolvencies, including a summary of receipts and payments and a statement that they have reconciled their accounts

- (iv) That where no Liquidation or Creditors' committees have been appointed it is open to any creditor to apply to court for an order that the Respondents do provide such information as might otherwise be required by Rule 4.108(3) or Rule 6 126(2) (or otherwise) (as the case may be) that is to say, an account of their administration of such insolvencies, including a summary of receipts and payments and a statement that they have reconciled their accounts, provided such an application is made within 28 days of this Order
- (v) That if the Respondents are required to provide the information referred to in paragraphs 6(iii) or 6(iv) above the costs of doing so will, unless there are good reasons to the contrary, be paid as an expense of the administration, bankruptcy, voluntary arrangement or winding up as the case may be.
- (vi) That each creditor and member (as the case may be) in respect of each of the insolvencies has a right under rule 11(1) (compulsory winding up), rule 11(2) (voluntary winding up) or rule 25 of the Insolvency Regulations 1994 (as the case may be) to require the supply of a statement of receipts and payments free of charge.

7. In relation to those administrations, liquidations or bankruptcies which have a Creditors' or Liquidation Committee, the Respondents shall notify the Creditors' or Liquidation Committee (as the case may be) of this Order and shall, if requested to do so by them within 28 days of receipt by them of a copy of this Order, prepare and provide them as soon as reasonably practicable with an account of their administration of such administrations, liquidations, voluntary arrangement or bankruptcies.

8. (a) The remuneration of and the costs and expenses incurred by the Applicant and/or the Respondents in connection with this Application and the implementation of this Order which are referable to an individual matter listed in the Schedule hereto be fixed and paid in the ordinary way as remuneration of the Liquidator, Administrator, Voluntary Arrangement or Trustee in Bankruptcy, or

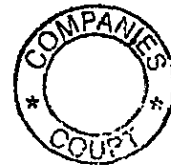
as costs and expenses of such liquidation, administration, voluntary arrangement or bankruptcy; and

- (b) The remuneration of and the costs and expenses incurred by the Applicant and/or Respondents in connection with this Application and the implementation of this Order which are referable to the Application generally be divided equally between all the matters listed in the Schedule hereto, and that the same be paid in the ordinary way as remuneration of the Liquidator, Administrator, Supervisor or Trustee, or as costs and expenses of each such liquidation, administration, voluntary arrangement or bankruptcy;

PROVIDED THAT in no case shall the total of such remuneration, costs and expenses (including VAT) payable under 8(a) and 8(b) above exceed 10% of the value of the realised assets in that particular matter.

9. There be liberty to apply to any Creditor of the companies or individuals referred to in the Schedule within 28 days of placing of the advertisement referred to in paragraph 6 above:
- (i) to vary or discharge this Order; and
  - (ii) in the bankruptcies, liquidations, voluntary arrangements and administrations other than those in paragraph 7 above, for an Order that the Respondents should prepare and provide them with an account of their administration of such insolvencies.
