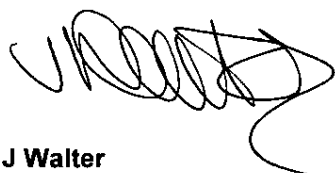

#### **4 ULTIMATE PARENT COMPANY**

Until 3 September 2007 First Choice Holidays Limited (formerly First Choice PLC), a company registered in England and Wales was the ultimate parent company.
