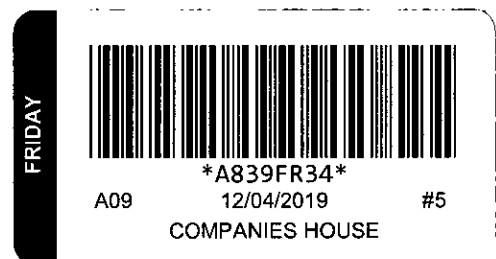
We hereby offer our resignation as auditor to British Overseas NGOs for Development (BOND) as of this date.
