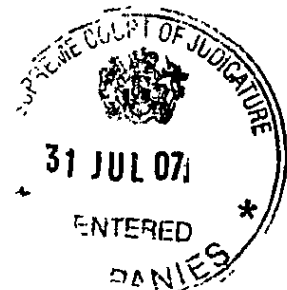

BY CONSENT it is ordered that

- 6 The Third Respondent be removed from his office of Liquidator of the Liquidations set out in the attached schedule in the cases initialled by the Judge.
- 7 The Applicant be appointed Liquidator of the Liquidations set out in the attached schedule in place of the First Respondent in the cases initialled by the Judge.
- 8 The Applicant be appointed as Administrator of the Administrations set out in the attached schedule in place of the First Respondent in the cases initialled by the Judge.
- 9 The Applicant and Fourth Respondent be appointed as Joint Liquidators of the Liquidations set out in the attached schedule in place of the First Respondent in the cases initialled by the Judge
- 10 The Fourth Respondent be appointed as Administrator of the Administration set out in the attached schedule in place of the First Respondent in the case initialled by the Judge.
- 11 The Sixth Respondent be appointed as Liquidator of the Liquidations set out in the attached schedule in place of the First Respondent in the cases initialled by the Judge.
- 12 The Ninth Respondent be appointed as Administrator of the Administration set out in the attached schedule in place of the Second Respondent in the case initialled by the Judge
- 13 The Applicant and the Ninth Respondent be appointed as Joint Liquidators of the Liquidation set out in the attached schedule in place of the First Respondent in the case initialled by the Judge
- 14 The Applicant and the Sixth Respondent be appointed as Joint Liquidators of the Liquidations set out in the attached schedule in place of the First and Third Respondents in the cases initialled by the Judge.
- 15 The Applicant and the Sixth Respondent be appointed as Joint Liquidators of the Liquidation set out in the attached schedule in place of the Third Respondent in the case initialled by the Judge.
- 16 The costs of this Application be an expense of the administrations and liquidations and be apportioned rateably, save to the extent that where funds are not available in certain of these insolvencies costs will be attributed to those administrations and liquidations where funds are available, for the purpose of discharging the costs of this Application, provided that costs payable pursuant to this Order in relation to any particular insolvency shall not exceed 10% of the value of the received assets in that particular insolvency.

- 17 There be liberty to each creditor or member of the estates listed in the attached schedule to apply to vary or discharge this Order in so far as it relates to an estate of which that person is a creditor or member within 28 days of being given notice of the same.
- 18 That the Applicant or, where appropriate, the relevant Respondent, will cause notice of the change in office holders to be advertised in the London Gazette or other appropriate publication within 14 days of the date of the order, such advertisement to include an explanation of the effect of the order and notice that any creditor may within 28 days of receiving notice of the order make an application to Court to challenge the order. The Applicant or, where appropriate, the relevant Respondent, will include notice of the change in office holders in their next written report to creditors.
- 19 Pursuant to Rule 7 4(6) of the Insolvency Rules 1986 the need to serve application upon the Respondents be dispensed with
