Directors' Report For the year ended 31st March 2004

The directors submit their report on the affairs of the company, together with the audited financial statements for the year ended 31 March 2004.

Principal activities and business review

The principal activity of the company in the year under review was that of Trustee to the PayPoint Risk Fund. The fund is set up on behalf of PayPoint clients and is used to provide against bad debt and debt collection costs. The company does not trade and accordingly no profit and loss account has been presented.

From 1st April 2002, PayPoint's clients made no further contributions to the risk fund and the risk fund was wound down with clients paying for bad debts and collection charges as and when they are incurred.

During the year the Trust incurred no costs or received no income.

Directors' responsibilities

Company law requires the directors to prepare accounts for each financial year which give a true and fair view of the state of affairs of the company and of the profit and loss of the company for that period. In preparing those accounts, the directors are required to:

- select suitable accounting policies and then apply them consistently;
