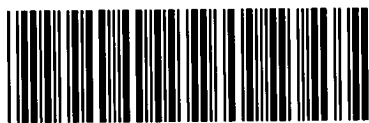

The company has taken advantage of the exemption in FRS No. 1 from producing a cash flow statement on the grounds that it is a small company.


