Figure 1. The effect of the concentration of the *Agrobacterium* strain on the transformation efficiency of *Agrobacterium* strain 101. The *Agrobacterium* strain 101 was cultured in the YEA medium for 24 h and then the cell concentration was adjusted to 10⁸ cells/ml. The cell suspension was mixed with the plant extract and the mixture was incubated for 24 h at 25°C. The plant extract was then transformed with the *Agrobacterium* strain 101. The transformation efficiency was determined by the number of transformants per 10⁶ cells. The data were expressed as the mean ± SD of three independent experiments.
