1. ACCOUNTING POLICIES

Basis of preparing the financial statements - going concern

The company is dependent on the support of its director Mr S Sethi, who was owed £69,344 (2014: £78,751) by the company at the balance sheet date. There is no intention by the director to seek repayment of the balance until the company is in a position to have sufficient funds and the director will continue to provide ongoing support to the company for the foreseeable future. The going concern basis is therefore considered to be appropriate.

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

Turnover

Turnover represents net invoiced sales of goods, excluding value added tax.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Fixtures & fittings - 20% on cost Office equipment - 33% on cost

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.
