1 Accounting policies

There have been no changes to accounting policies during the period

Basis of preparation

The financial statements have been prepared in accordance with applicable accounting standards and under the historical cost convention

The company is exempt by virtue of s228 of the Companies Act 1985 from the requirement to prepare group accounts. These financial statements present information about the company as an individual undertaking and not about its group. Group accounts have not been prepared since the company is a wholly owned subsidiary of Synexus Clinical Research Plc, who has itself prepared group accounts.

The company is wholly controlled by Synexus Limited It has taken advantage of the exemption contained in Financial Reporting Standard 8 and has not disclosed transactions or balances with entities which form part of the group
