UPON THE APPLICATION OF Andrew Tate (1) James Hopkirk (2) (together the "Applicants") dated 10 May 2018.

**AND UPON READING** an email from the Insolvency Service on behalf of the Secretary of State and the Senior Official Receiver dated 12 June 2018 indicating that they have no objection to the making of the orders sought

**AND UPON READING** the documents filed in support of the application

**IT IS ORDERED** that:

1. If not already within the jurisdiction of the High Court of Justice, the cases listed in the Schedules of Cases attached hereto and referred to as being in the County Court of (if appropriate) being in a District Registry ("the other Courts") be transferred to the High Court of Justice, Companies Court (Chancery Division) for the purpose only of making this Order.
2. Immediately upon this Order taking effect, the cases listed in the Schedules of Cases attached hereto be transferred back to the County Courts and the other Courts.
3. In relation to the Bankruptcy cases identified in Schedule A-1 to this Order, Maxine Reid be removed as Trustee in respect of each of the cases from the date of this Order and James Hopkirk be appointed as Joint Trustee in Bankruptcy with Andrew Tate.
4. In relation to the Bankruptcy case identified in Schedule A-2 to this Order, Maxine Reid be removed as Trustee from the date of this Order and Andrew Tate be appointed as Joint Trustee in Bankruptcy with Laurence Pagden.
5. In relation to the Administration cases identified in Schedule B to this Order, Maxine Reid be removed as Administrator from the date of this Order and James Hopkirk be appointed as Joint Administrator with Andrew Tate.
6. In relation to the Creditors' Voluntary Liquidations identified in Schedule C-1 to this Order, Maxine Reid be removed as Liquidator from the date of this Order and James Hopkirk be appointed as Joint Liquidator with Andrew Tate.
7. In relation to the Creditors' Voluntary Liquidations identified in Schedule C-2 to this Order, Maxine Reid be removed as Liquidator from the date of this Order and Andrew Tate be appointed as Joint Liquidator with Lee De'ath, Ian Michael Rose and Elias Paourou respectively.
8. In relation to the Compulsory Liquidations identified in Schedule D to this Order, Maxine Reid be removed as Liquidator from the date of this Order and James Hopkirk be appointed as Joint Liquidator with Andrew Tate.
9. In relation to the Members' Voluntary Liquidations identified in Schedule E to this Order, Maxine Reid be removed as Liquidator from the date of this Order and James Hopkirk be appointed as Joint Liquidator with Andrew Tate.

10. In relation to the Individual Voluntary Arrangement identified in Schedule F to this Order, Maxine Reid be removed as Supervisor from the date of this Order and James Hopkirk be appointed as Joint Supervisor with Andrew Tate.
11. In relation to the Company Voluntary Arrangement identified in Schedule G to this Order, Maxine Reid be removed as Supervisor from the date of this Order and James Hopkirk be appointed as Joint Supervisor with Andrew Tate.
12. Maxine Reid is released from liability in relation to her conduct as office-holder of the companies and individuals as are listed in the Schedules of Cases attached hereto from 56 days after filing notice of her removal with the Registrar of Companies or the giving of notice to creditors of the relevant estate in accordance with this Order, save that such release may be subject to further order in the event of an application by any creditor / member under paragraph 13 (b) of this Order for the specific case subject to that application.
13. The First and the Second Applicant shall procure that, at the first convenient opportunity to, and in any event, within 3 months of the date of this Order, publish an advertisement in relation to each of the estates set out in the Schedules of Cases attached hereto in the London Gazette. Such advertisements shall contain notification of the following matters:
  - a. The substitution and / or the removal of Maxine Reid and details of that substitution and / or removal;
  - b. That any creditor (or in the case of any members' voluntary liquidations, any member) in respect of any of the companies or persons listed in the Schedules of Cases attached hereto who has an objection to this Order shall have 28 days from the date of the advertisement to apply to the Court to set aside or vary this Order. Such application shall not affect the transfer of that specific case until further or other order by the Court;
  - c. In the cases of each bankruptcy and liquidation, that:
    - i. The costs of complying with a request of the committee or creditor for an account of Maxine Reid's administration of the relevant estate should be an expense of the insolvency proceedings.
    - ii. Maxine Reid will be entitled to apply to the Secretary of State for her release within 56 days after the notice has been advertised.
14. The First and the Second Applicant, as replacement office-holders, shall lodge a copy of this Order for each case under the jurisdiction for filing on the respective court file as soon as reasonable practicable.
15. There is no order as to costs.

16. The First and the Second Applicant, as replacement office-holders, shall give notice to the Secretary of State in respect of the cases listed in the Schedules of Cases attached hereto of the terms of this Order as soon as practicable.
17. The First and the Second Applicant, as replacement office-holders, shall give notice to the Registrar of Companies in respect of the liquidations, administrations and voluntary arrangements listed in Schedule B, C-1, C-2, D, E and G attached hereto of the terms of this Order as soon as reasonably practicable.
18. Nothing in this Order shall release the First Respondent, Maxine Reid, from any obligation to give and file notices in respect of her removal under this Order in respect of the cases referred to in the Schedules of Cases attached hereto.
