

#### **DIRECTOR'S REPORT**

The Directors report and Financial Statement for the period 1<sup>st</sup> MAY 2016 to 30<sup>TH</sup> APRIL 2017 and certify it to be in accordance with its books and records held by the company. This gives a true and fair view of the company's transactions during this period.

#### 1. ACTIVITIES

The principal activities of the company are providing advice and help on community problems. To provide activities aimed at older people combating isolation.

#### 2. REVIEW OF ACTIVITIES

The Company has been successful in providing help, advice and surgeries, which have been used constantly by the public.

ARCH has been working with other local agencies to increase the number of services for excluded groups in gaining access to information and activities. The total beneficiaries' accessing these services & activities for this year equates to 2953 a significant decrease on last year's figures, The trustee's feel that this is due to the office being closed while the only paid worker is attending meetings and also while delivering activities on a different site. To move forward on this the trustee's feel that funding should be sort for a part time worker. The organisation has been, again, working in partnership with local housing groups, Councillors, South Liverpool Neighbourhood Management Team, Liverpool City Council, Youth providers, Beat abuse & police tackling housing problems, youth nuisance and area concerns. The organisation has also been working with Local councillors and Liverpool City council tackling issues around Debt and food poverty.

The organisation has been successful in delivering coffee morning sessions to bereaved and isolated members of our community. The group has implemented their own annual holidays and outings during winter months.

Again, through securing funding from the Mayors Hope Fund we have been able to tackle food poverty delivering 'food' activities two both of our local primary schools & older members of our community, These groups are known as 'Little Dibbers' – 7 to 8 Yr olds and 'Potters'. Both of these groups are engaged in 'growing food' activities on an allotment site. Whilst both groups were attending sessions they received a 'hot or cold' meal.

ARCH has delivered their annual Santa Christmas Street Float aimed at the whole community providing a bit of Christmas Spirit. We have held 2 open day events on our allotment site, raising awareness to the young and old. To combat ASB youth nuisance ARCH has been attending (YAR) Youth at Risk meetings with local agencies.

And finally for this year ARCH had 9 dedicated volunteers to help with events and projects as with our working partnerships, sponsors and funders we appreciate all their Time, help, support and guidance as without them we could not achieve or deliver the projects and events meeting our deprived community's needs.
