The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed an intercompany debt of £13 07 due from British Sky Broadcasting Limited ("BSkyB Ltd") The debt has been distributed by assignment to the beneficial shareholder of the Company, British Interactive Broadcasting Holdings Limited (see "Distributions" below)

The Company had no known creditors However, a number of possible contingent creditors were identified during the pre-liquidation due diligence phase and the relevant parties were invited to prove their claims, if any, in the liquidation. In addition, notices to creditors to prove their claims in the liquidation were advertised in The London Gazette and The Times Newspaper on 27 July 2012. In the event, no creditors were forthcoming.

Searches of the Index of Proprietors Names at HM Land Registry (in the Company's current and former names) proved negative

Tax

All pre liquidation corporation tax matters were handled by BSkyB Ltd who prepared and submitted all outstanding returns to the date of the commencement of the liquidation to HM Revenue and Customs ("HMRC") The joint liquidators sought and received confirmation from HMRC that the Company had no outstanding corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the liquidators calling a final meeting of members to conclude the liquidation

A similar assurance was sought and received from HMRC in respect of PAYE and VAT matters

Distributions

On 29 January 2014 the joint liquidators declared a first and final distribution of the assets of the Company to British Interactive Broadcasting Holdings Limited, as the beneficial shareholder of the Company

The distribution was at the rate of £0 000000019833080 per £1 ordinary share and was effected by the assignment of the debt of £13 07 due to the Company by BSkyB Ltd

Replacement of liquidator

Please note that on 14 August 2013 an order was made in the High Court appointing Allan Watson Graham as Joint Liquidator of the Company in place of Jeremy Simon Spratt, following Mr Spratt's retirement from KPMG LLP. In accordance with the Order, creditors and members were given notice of the Order by advertisement in the London Gazette on 21 August 2013

Joint liquidators' remuneration and expenses

A written resolution was passed on 28 June 2012 that the remuneration of the joint liquidators be fixed at their normal charging rates according to the time properly spent by them and members of their staff in attending to matters arising in the winding up of the Company.

In the event, the liquidators' remuneration will be paid by BSkyB and accordingly no detailed analysis is included in this report.
