The company has the following related undertakings by virtue of a common management committee:

Hackney Community Transport – A charitable company limited by guarantee, formed as a non-profit-making community transport organisation. At the year end date Hackney Community Transport owed Hackney Community Recycling £1,000 (2005 – £1,000).

Transport Co-ordination Centre Hackney Limited – A company limited by guarantee, formed to co-ordinate transport within the London Borough of Hackney to increase the provision available to elderly users, people with disabilities and those attending leisure and education facilities. At the year end date Hackney Community Recycling owed Transport Co-ordination Centre Hackney Limited £nil (2004 – £nil).

C T Plus Limited – a wholly owned subsidiary of Hackney Community Transport. At the year end date CT Plus Limited owed Hackney Community Recycling £1,500 (2005 – £1,500).
