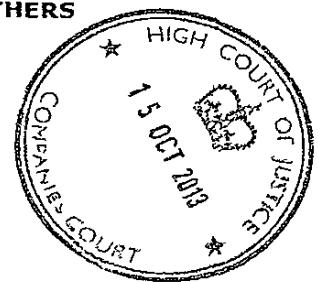

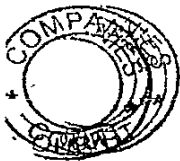
UPON the application of the above name Applicants made by an application notice dated 12 September 2013

AND UPON reading the attached documents recorded on the Court file as having been read it is ordered that:-

- 1 The proceedings listed in the Schedules as being in the Manchester, Birmingham and Worcester District Registries shall be transferred to the High Court for the purposes only of the making of an Order pursuant to the Application Notice, whereupon those proceedings shall be transferred back to the relevant District Registry.
- 2 In relation to the Creditors Voluntary Liquidations as set out in Schedule A, Part 1:
 - a The Respondent shall be removed as Liquidator; and
 - b The First Applicant shall continue in office as sole Liquidator.

 - b. The Second Applicant shall continue in office as sole Administrator.
6. In relation to the Administration as set out in Schedule B, Part 3:
 - a. The Respondent shall be removed as Joint Administrator, and
 - b. The Fourth Applicant shall continue in office as sole Administrator.
