### **ORDER**

**UPON** the application of the Applicants by Notice of Application lodged on September 2004

AND UPON hearing Counsel on behalf of the Applicant



AIQ 06/01/2012 COMPANIES HOUSE

AND UPON the Respondents being neither present nor represented but having consented to the making of the Orders set out below

AND UPON reading those documents recorded upon the Court file as having being read

### IT IS ORDERED that -

- In respect of the bankruptcies, creditors voluntary liquidations, administration orders, company voluntary arrangements ("CVAs") and compulsory liquidations listed in Schedule 1 to this Order which are the subject of proceedings in County Courts and District Registries, those proceedings be transferred to the High Court solely for the purpose of making the Orders below
- The Respondents be removed from office as Trustees in Bankruptcy, CVA Supervisors and Liquidators (compulsory or voluntary) administrators or receiver of the estates listed in Schedule 1 with immediate effect.
- 3. In the case of each such estate the Respondents be replaced as office holders by the Applicants who are the proposed replacement appointee named in the relevant column in Schedule 1 with immediate effect. In the case of each such estate where either of the Applicants, Rob Sadler and Michael Ellingworth, are already appointed joint officeholder together with either of the Respondents, that Respondent be removed and the Applicant, Rob Sadler or Michael Eillingworth, do remain as the sole officeholder with immediate effect
- 4. The Applicants be entitled to publish in the Gazette one composite notice relating to all new appointments which are required by law to be published in the Gazette
- Without incuming any additional expense to any of the said estates (save in respect of the estates relating to bankruptcies and compulsory liquidation) the applicants shall, when the next routine report is due to the creditors of each estate notify each creditor, or member of the making of this order. In the bankruptcies and compulsory liquidations notice is to be provided by letter

(and it is recognised that such letters will cause an additional expense to be incurred to such estates). Such notice or letter, as the case may be, is to be sent within 28 days of this order and is to contain the following matters -

- 5.1 An explanation of the effect of the Orders.
- 5.2 Express reference to the liberty to apply contained in paragraph 6 below
- 5.3 In the case of CVAs, the provision of all such information as might reasonably be required with regard to the conduct of the Voluntary Arrangement
- 5.4 In the case of bankruptcies and liquidations, the provision of all such information as might reasonably be required as part of that report with regard to the conduct of the bankruptcy or liquidation (as the case may be)
- In the case of creditors voluntary liquidations, compulsory liquidations and bankruptcies under the Insolvency Act 1986 where liquidation or creditors committees have been appointed, an explanation as to the extent that any such information which would otherwise be required to be provided under Insolvency Rule 4 108(3) or Rule 6 126(2) has not already been provided as part of the routine report, it is open to that Committee to require the Application appointed to provide an account of the administration of the estate including:-
  - 5.5.1 summary of receipts and payments

- 5 5.2 a statement that he has reconciled his accounts
- In the case of creditors voluntary liquidations, compulsory liquidations and bankruptcies, under the Insolvency Act 1986, where no liquidation or creditors committee have been appointed, an explanation that, to the extent that such information has not already been provided as part of the routine report, it is open to any creditor to apply to Court for an Order that the Applicant appointed do provide such information as might otherwise be required by Rule 4 108(3) or Rule 6.126(2) (as the case may be) that is to say, an account of the administration of the estate, including:-
  - 5 6.1 summary of the receipts and payment
  - 5.6.2 a statement that he has reconciled his accounts
- In the case of administrations under the Insolvency Act 1986 an explanation that, to the extent that such information has not already been provided as part

of the routine report, it is open to any creditor to apply to the Court for an Order that the Applicant appointed do provide such information as might otherwise be required by Rule 2 52(3)(b) that is to say, receipts and payments curing the period from the end of the last 6 month period to the time when the Respondent ceased to act or in the period since the Respondent's appointment if there has been no previous abstract receipts and payments

- 5.8 In the case of Refractory Linings (Leeds) Limited In Administrative Receivership, the Second Respondent be removed as Administrative Receivers
- Notification that if any Applicant appointed has been required to provide the information referred to above, whether by the liquidation/creditors committee or by Court Order on the application of any individual creditors or (in the case of members voluntary liquidation) any individual members, the appointed Applicant's costs of so complying will, unless there are good reasons to the contrary, be paid as an expense of the bankruptcy or winding-up as the case may be.
- In the case of liquidation under the Insolvency Act 1986, notification of each creditor of his right under Rule 11(1) (compulsory winding-up) and Rule 11(2) (voluntary winding-up) of the Insolvency Regulations 1994 to require the appointed Applicant to supply a statement of receipts and payments free of charge.
- 5.11 In the case of bankruptcies under the Insolvency Act 1986, notification to each creditor of his right under Rule 25 of the Insolvency Regulations 1994 to require the appointed Applicant to supply a statement of receipts and payments free of charge
- 6 Liberty to each creditor of each estate, and each member of any company identified in Schedule 1 to apply to vary or discharge this Order within 21 days of receipt of the notices or letters directed to be sent under paragraph 5 above.
- 7 The costs of this Application (including VAT) to be aggregated and apportioned equally between each of the estates listed in Schedule 1 save

that such costs which are payable in relation to the each of the estates shall not exceed 10 per cent of the value of the realised assets in that particular estate.
