

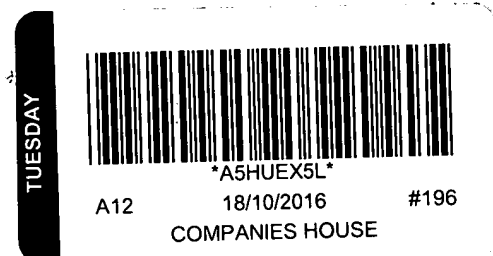

PRINCIPAL ACTIVITIES AND REVIEW OF THE BUSINESS




