

1. General information

The Company is a private company (limited by shares) and is registered in England and Wales. The registered number is 03597813. The registered office is Parkway House, Unit 6, Parkway Industrial Estate, Pacific Avenue, Wednesbury, West Midlands, WS10 7WP.
