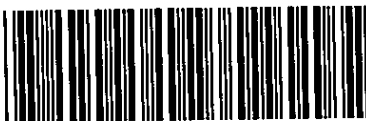

IT IS ORDERED THAT -

1 **APPLICANT'S REMOVAL AS OFFICE HOLDER**

1.1 The Applicant be removed as office holder in the cases set out in the Schedules hereto pursuant to the relevant power set opposite each category below with effect from the date of this Order -

- 2 1 Dan Mindel be appointed in substitution for the Applicant as joint office holder with Samantha Keen for the matters set out in Schedule 1
- 2 2 Dan Mindel be appointed in substitution for the Applicant as joint office holder with Elizabeth Anne Bingham for the matters set out in Schedule 2
- 2 3 Dan Mindel be appointed in substitution for the Applicant as joint office holder with Maurice Moses for the matter set out in Schedule 3
- 2 4 Dan Mindel be appointed in substitution for the Applicant as joint office holder with Angela Swarbrick for the matter set out in Schedule 4
- 2 5 Richard Barker be appointed in substitution for the Applicant as joint office holder with Samantha Keen for the matters set out in Schedule 5

3 ADVERTISEMENT, REPORTING TO MEMBERS AND CREDITORS AND RELEASE

- 3 1 As soon as reasonably practicable, and in any event within 28 days of the date of this Order, the Applicant shall procure that a block advertisement is placed in the London Gazette. The advertisement shall contain notification of the removal of the Applicant from the cases identified in the Schedules hereto and the appointment of the relevant Respondent in her place and shall be in substitution for notifying each individual member or creditor on each estate (as applicable), save to the extent provided for at paragraph 3.2 below
- 3 2 The Respondents shall at the first convenient opportunity, and in any event when the next routine report is due to the members or creditors of each estate (as applicable) or within twelve months following the making of this Order, whichever is sooner, notify such members or creditors of the making of this Order, such notice to contain the following matters -
- 3 2 1 an explanation of the effect of this Order, and
- 3 2 2 express reference to the liberty to apply contained in paragraph 5 below
- 3 3 In relation to the cases listed in the Schedules hereto, and insofar as the Insolvency Act 1986 or the Insolvency Rules 1986 contain any requirement for any appointment of an office holder to be advertised, the requirement shall be dispensed with save to the extent provided for in paragraph 3 1 above



3 4 Without being required to apply to the Secretary of State for a release pursuant to Section 173(2)(b) of the Insolvency Act 1986 and Rules 4.144(3) and 4.122(3) of the Insolvency Rules 1986, the Applicant shall be granted her release in respect of each case on the later of 28 days after the publication in the London Gazette referred to in paragraph 3.1 above or 28 days after receipt of any of the notices directed to be sent under paragraph 3.2 above in respect of that case

4 DISPENSATION WITH REQUIREMENTS TO FILE PROGRESS REPORTS AND RECEIPTS AND PAYMENTS ACCOUNTS

4.1 The Applicant and the Respondents be authorised to dispense with any requirement for a progress report or a receipts and payments account in any of the cases set out in the Schedules hereto as a consequence of the removal of the Applicant as an office holder or the appointment of the incoming office holders, and the Respondents to send progress reports and receipts and payments accounts in the normal way

5.1 There be liberty to each member or creditor (as applicable) of each estate set out in the Schedules hereto to apply to vary or discharge this Order within 28 days of receipt of the notices directed to be sent under paragraph 3.2 above
