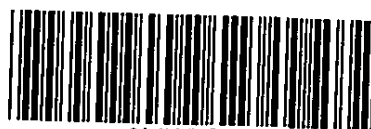
AND IT IS ORDERED THAT the further advertisement of the Petition be dispensed with
