1. REPORTING ENTITY

These financial statements are prepared for Bondclear Limited (the "Company'), which is dormant. The Company is a wholly owned subsidiary of LCH Limited and its ultimate parent company is London Stock Exchange Group plc.

The Company is a private limited company, incorporated in the United Kingdom and registered in England & Wales.

2. SHARE CAPITAL

Particulars of the Company's share capital are as follows:

The issued share capital of the Company is £1, (2015: £1), comprising of 1 (2015: 1) ordinary share of £1 (2015: £1).

3. RELATED PARTY TRANSACTIONS

There have been no transactions with related parties requiring disclosure in either 2016 or 2015. The Company is dormant and all statutory fees are paid by the parent company.
