ORDER

UPON READING the Application dated 26 May 2016 pursuant to Rule 7 10A and Chapter 1A of the Insolvency Rules 1986



AND UPON READING the Witness Statements of Dean Watson dated 26 May 2016 and 9 June 2016 and the Consents to Act of the Applicants contained in the exhibit marked "DW4" of the statement of Dean Watson

IT IS ORDERED that -

- 1 In respect of those Creditors' Voluntary Liquidations, Administrations, Compulsory Liquidations, Company Voluntary Arrangements, Members' Voluntary Liquidations and Bankruptcies listed in the Schedules to this Application which are the subject of proceedings in the County Court, those proceedings be transferred to the High Court solely for the purpose of this Application and thereafter transferred back to the relevant County Court
- 2 The Respondents be removed from office as office holders of the companies and bankruptcy estates (as the case may be) over which they are referred to as the current appointees in the attached schedules
- 3 The Respondents be replaced as office holders of the cases referred to in paragraph 2 above by the Applicants in accordance with the terms of the attached schedules
- 4 In the cases where the Respondents are being replaced in the office of Administrator, the Applicants replacing them in each case shall additionally replace them as the nominated liquidators where and to the extent that the Respondents are referred to as the nominated liquidators for any future liquidation in the Administrators' proposals which have been approved by the creditors
- 5 The removal and appointments granted by this Order shall not disturb the existing reporting cycle for each of the respective insolvency appointments listed in the Schedules and the current time limit for reporting to creditors on each of the insolvency appointments shall continue irrespective of the removal and appointments made by this Order
- 6 The provisions contained in Insolvency Rules 2 47(3A), 4 49 (b) (5) and 4 49C-CVL(3) and of the Insolvency Rules 1986 or any other such reporting requirements shall not apply and the Respondents are not required to produce any progress reports on ceasing to act as officeholder of the insolvency appointments listed in the Schedules
- 7 The Respondents be granted their release as office holders of the cases referred to in paragraph 2 of this order 21 days after the publication in the London Gazette referred to below
- 8 The Applicants be entitled to publish in the London Gazette one composite notice relating to all new appointments which are required by law to be published in the Gazette within 14 days of receipt of the sealed Order and shall file any appropriate notices in respect of the removal of the Respondents, the appointment of replacement office holders, and those appointments with the Registrar of Companies and the Secretary of State for Business Innovation and Skills (Insolvency Services) as appropriate
- 9 Notice of this Order shall be given to the creditors in each case in the next statutory report for each insolvency administration listed in the Schedules

- 10 The cost of placing notice of this Order in the London Gazette (but not the costs of this Application) be aggregated and be drawn as a proper expense of each of the cases listed in the Schedules which shall bear an equal proportion of such costs and disbursements where sufficient funds are available, save that an expense borne by a Company Voluntary Arrangement that would cause it to fail as a result of a breach of its terms shall not be subject to such apportionment
- 11 If in any of the cases listed in the Schedules there are insufficient funds to bear that case's ostensible share of the cost of placing the Notice in the London Gazette, the Applicants may apportion that case's share of the cost among the other cases listed in the Schedules at their discretion
- 12 Liberty for the creditors of each of the companies and the bankruptcy estates to apply to vary or discharge this Order within 21 days of the date of publication in the London Gazette Notice directed to be published under paragraph 11 above
- 13 The costs of the Application be an expense of the insolvency proceedings set out in the Schedules hereto and be apportioned rateably, provided that the costs payable pursuant to the Application in relation to any of the insolvency proceedings set out in the Schedules shall not exceed 10% of the value of the perceived assets in that particular insolvency proceeding,
- 14 Service of Notice of the Application be dispensed with
