INTRODUCTION

Pioneer Weston International Limited (Entity) entered members' voluntary liquidation on 29 April 2019. Emma Cray and David Matthew Hammond were appointed joint liquidators of the Entity (Liquidators).

This account covers the conduct and progress of the liquidation in the period from 29 April 2019 to 10 March 2020 (Period). This is the Liquidators' final account of the liquidation.

A summary of receipts and payments in the liquidation is at Appendix A.

The statutory information relating to the Entity and the Liquidators is at Appendix B.

REPORT ON THE LIQUIDATION

Realisation of assets:

Following their appointment, the Liquidators took control of the assets listed in the Declaration of Solvency; these being an inter-company balance due from Wyko Group Limited totalling £380,006

The Liquidators have not identified any additional assets of the Entity and are not aware of any other assets that remain to be realised.

Settlement of liabilities:

The directors' Declaration of Solvency showed that the Entity had no liabilities.

In the Period, the Liquidators published a notice in the London Gazette inviting creditors to submit details of claims they may have against the Entity.

The Liquidators have not received any claims in the liquidation.

HM Revenue & Customs ("HMRC"):

Following their appointment, the Liquidators wrote to HMRC to inform them of the liquidation and to request details of any outstanding liabilities. HMRC have confirmed that the Entity has no outstanding tax liabilities and that they have no objection to the liquidation being closed.

Distributions to Members:

On 10 February 2020, an in specie distribution of £380,006 (representing approximately £1.09 per share) was made to the Member of the Entity. The value attributed to the distribution was based on the value at which the asset was held in the Entity's books.

The distribution in specie consists of an intercompany debtor due from Wyko Group Limited.
