AGREEMENT dated 5th January 1999



BETWEEN:-

- (1) **THE SAVOY GROUP LIMITED** (in liquidation) a limited liability company incorporated in England and Wales with registered number 3669289 and whose registered office is at 1 Savoy Hill, London WC2R OBP ("Newco") acting by the Liquidators as set out below;
- (2) **JAMES ROBERT DRUMMOND SMITH** and **NICHOLAS JAMES DARGAN** of Deloitte & Touche, 1 Stonecutter Street, London EC4A 4TR (the "Liquidators");
- (3) **SAVREG A LIMITED** (to be re-registered as The Savoy Hotel Limited on or around 4th January 1999) a limited liability company incorporated in England and Wales with registered number 3669255 and whose registered office is at 1 Savoy Hill, London WC2R OBP ("Savreg A");
- (4) **THE BERKELEY HOTEL LIMITED** a limited liability company incorporated in England and Wales with registered number 3669260 and whose registered office is at 1 Savoy Hill, London WC2R OBP ("The Berkeley");
- (5) **CLARIDGE'S HOTEL HOLDINGS LIMITED** a limited liability company incorporated in England and Wales with registered number 3669265 and whose registered office is at 1 Savoy Hill, London WC2R OBP ("Claridges Holdings");
- (6) **THE CONNAUGHT HOTEL LIMITED** a limited liability company incorporated in England and Wales with registered number 3669273 and whose registered office is at 1 Savoy Hill, London WC2R OBP ("The Connaught");
- (7) **THE LYGON ARMS HOTEL LIMITED** a limited liability company incorporated in England and Wales with registered number 3669276 and whose registered office is at 1 Savoy Hill, London WC2R OBP ("The Lygon Arms");
- (8) **SAVOY THEATRE HOLDINGS LIMITED** a limited liability company incorporated in England and Wales with registered number 3669280 and whose registered office is at 1 Savoy Hill, London WC2R OBP ("Theatre Holdings");
- (9) **SAVOY MANAGEMENT SERVICES LIMITED** a limited liability company incorporated in England and Wales with registered number 3669284 and whose registered office is at 1 Savoy Hill, London WC2R OBP ("SMS");
- (10) **BLACKSTONE HOTEL ACQUISITIONS COMPANY** an unlimited liability company registered in England and Wales (registered number 3543429) whose registered office is at 1 Savoy Hill, London, WC2R OBP ("BHAC");
- (11) **BRE/SATELLITE LP**, a limited partnership constituted under the laws of Delaware USA and having its principal place of business at 345 Park Avenue, New York, NY [10154], USA ("BRE/Satellite");
- (12) **THE SAVOY HOTEL LIMITED**, a limited liability company registered in England and Wales (registered number 29022) (to be re-registered on or about 4th January

1999 as Claridge's Hotel Limited) whose registered office is at 1 Savoy Hill, London, WC2R OBP ("The Savoy").

**WHEREAS:-**

- (A) On 31 December 1998, each of the Dormant Subsidiaries transferred the legal title to the Business Premises registered in its name to The Savoy.
- (B) On 1 January 1999, Newco, being the sole shareholder of The Savoy, approved, and there was paid, a dividend by The Savoy which was satisfied by the distribution in specie of The Savoy Theatre Shares and the Businesses (other than certain assets and liabilities of such Businesses) to Newco, conditional upon Newco entering into the Distribution and Transfer Agreement.
- (C) On 1st January 1999, certain assets relating to each of the businesses distributed in specie to Newco were sold for cash by The Savoy to Newco on the terms set out in the Distribution and Transfer Agreement.
- (D) By special resolution of Newco passed at an Extraordinary General Meeting held on 5th January 1999, Newco was placed into members' voluntary liquidation, the Liquidators were appointed for the purposes of winding-up the affairs of Newco and were authorised pursuant to Section 110 of the Insolvency Act to enter into and give effect to this Agreement.
- (E) It is intended that, pursuant to arrangements entered into under Section 110 of the Insolvency Act, Newco acting by the Liquidators will transfer each of the Businesses and the Shares to the relevant Transferees as set out in Schedule 2 in consideration in each case for the issue by each of the relevant Transferees of such numbers of A Shares to BHAC and B Shares to BRE/Satellite, in each case credited as fully paid, as are set out in columns (3) and (4) of Schedule 2 opposite the name of the relevant Transferee.
- (F) The Savoy is a party to this Agreement solely for the purposes of clause 7.4 of this Agreement.

**NOW IT IS AGREED** as follows:-

- 1.1 In this Agreement (including the recitals) the following words and expressions shall have the following meanings:-

"A Shares" means, in respect of each Transferee, "A" ordinary shares of 10p each in the share capital of that Transferee;

"B Shares" means, in respect of each Transferee, "B" ordinary shares of 10p each in the share capital of that Transferee;

"The Berkeley Business" means all of the business carried on by Newco in connection with and under the name "The Berkeley Hotel" at the Effective Date and including the Business Assets relating to The Berkeley Business

"Business Day" means any day, not including Saturdays or Sundays, on which commercial banks are generally open for business in England;

**"Businesses"** means The Savoy Business, The Berkeley Business, The Connaught Business, The Lygon Arms Business and the Residual Businesses;

**"Business Assets"** means, in respect of each of the Businesses, such right, title and interest as (i) Newco and (ii) The Savoy (as transferred to Newco pursuant to the Distribution and Transfer Agreement or otherwise, including without limitation, by way of the distribution in specie referred to in recital (B)), may have in the undertaking and assets of such Business of any nature whatsoever, including without limitation:

- (i) the Goodwill of Newco in relation to that Business, together with the exclusive right, in so far as Newco can grant it, for the relevant Transferee to represent itself as carrying on that Business in succession to Newco from the Effective Date, together with all trade names associated with that Business;
- (ii) all inventions, patents, registered designs, design rights, database rights and copyrights, know how and trade marks (whether registered or not) and the goodwill therein and applications for any of the same and right or forms of protection of a similar nature and having equivalent or similar effect to any of them which may subsist anywhere in the world ("Intellectual Property Rights") relating to or used in connection with that Business at the Effective Date
- (iii) all Contracts connected with that Business at the Effective Date;
- (iv) the Business Premises relating to that Business at the Effective Date;
- (v) the fixed plant, machinery, equipment, tools and effects and all other furniture and fittings owned and used by Newco in that Business at the Business Premises at the Effective Date;
- (vi) immovable plant and machinery, equipment and furniture owned and used by Newco in relation to that Business at the Effective Date; and
- (vii) the aggregate amount owed to Newco in connection with that Business by in or in respect of trade debtors, trade bills receivable and other debtors at the Effective Date and any cash in hand or at a bank relating to that Business at the Effective Date;
- (viii) any amount owed to Newco by The Savoy pursuant to clause 3.4 of the Distribution and Transfer Agreement to the extent that such amount relates to that Business;

but not including the Stocks and the Prepayments relating to that Business;

**"Business Premises"** means, in relation to each of the Businesses, the properties used or occupied by Newco in connection with that Business at the Effective Date, brief particulars of which are set out in Schedule 1;

**"Completion"** means completion as described in Clause 5;

**"Company Records"** means the records of Newco to which the Liquidators or HM Customs and Excise may be entitled from time to time as a matter of law or any other

records, papers and correspondence in the possession or control of Newco which the Liquidators consider in their sole discretion relate in whole or part to the liquidation of Newco together with the statutory books of Newco;

"**Contracts**" means the benefit (subject to the burden) of all contracts, engagements, obligations and arrangements of, and rights, benefits and licences enjoyed by, Newco of any nature whatsoever;

"**The Connaught Business**" means all of the business carried on by Newco in connection with and under the name "**The Connaught Hotel**" at the Effective Date and including the Business Assets relating to the Connaught Business;

"**Distribution and Transfer Agreement**" means the agreement entered into between The Savoy and Newco on or about 1st January 1999;

"**Dormant Subsidiaries**" means The Lygon Arms (398439) Limited, The Connaught Hotel (52242) Limited, The Savoy Hotel Laundry Limited, The Worcester Building Company Limited, Headfort Hotel (Belgravia) Limited, Mount Street Mansions Limited, Patrick Spitfire Limited, Speed 6060 Limited, Centralglen Limited and Claridges Hotel (42000) Limited;

"**Effective Date**" means 5th January 1999;

"**Employees**" means, in respect of each of the Businesses, all of the employees of Newco engaged in that Business (for the purposes of the Transfer of Undertakings of (Protection of Employment) Regulations 1981) immediately before the Effective Date whose names are set out in Parts 1 to 5 (as applicable in respect of each of the Businesses) of Schedule 3 and any other employee who is, or is deemed to be, employed by Newco following the transfer pursuant to the Distribution and Transfer Agreement;

"**Insolvency Act**" means the Insolvency Act 1986;

"**Intellectual Property Rights**" has the meaning given to it in the definition of "Business Assets" above;

"**Liabilities**" means all debts, liabilities and obligations of:

- (i) Newco; and
- (ii) The Savoy as assumed by or transferred to Newco or in respect of which Newco has indemnified The Savoy, in each case whether pursuant to the Distribution and Transfer Agreement or otherwise, including without limitation by way of the distribution in specie referred to in recital (B) but, without prejudice to sub-paragraph (i) above, excluding all those referred to in clauses 2.1 and 2.2 of the Distribution and Transfer Agreement in respect of which Newco has been irrevocably and unconditionally released (or will be irrevocably and unconditionally released on Completion) pursuant to the Distribution and Transfer Agreement.

of any nature whatsoever, howsoever and whenever incurred (whether or not yet due and payable and whether incurred or arising before or after the Effective Date or

whether present, future, certain or contingent) including without limitation those arising out of, or following, the execution and/or implementation of this Agreement;

"**Liquidation Date**" means 5th January 1999;

"**The Lygon Arms Business**" means all of the business carried on by Newco in connection with and under the name "**The Lygon Arms Hotel**" at the Effective Date and including the Business Assets relating to The Lygon Arms Business;

"**Prepayments**" means, in respect of each of the Businesses, the prepayments made on account of insurances, rates and similar items in relation to that Business at the Effective Date;

"**Residual Businesses**" means all of the businesses carried on by Newco set out in Part 5 of Schedule 3 and including the Residual Business Assets;

"**Residual Business Assets**" means all and any of those Business Assets which are not transferred to any of the Transferees as part of The Savoy Business, The Berkeley Business, The Connaught Business, The Lygon Arms Business and the transfer of the Shares;

"**Residual Liabilities**" means all or any Liabilities which are not transferred to, or assumed by, any of the Transferees as part of The Savoy Business, The Berkeley Business, The Connaught Business, The Lygon Arms Business or the transfer of the Shares;

"**Shares**" means The Savoy Theatre Shares and The Savoy Shares;

"**The Savoy Business**" means all of the business carried on by Newco in connection with and under the name "**The Savoy Hotel**" and/or Simpsons-in-the-Strand on the Effective Date and including the Business Assets relating to The Savoy Business;

"**The Savoy Shares**" means the 28,615,873 ordinary shares of 10p each in the capital of The Savoy registered in the name of Newco at the Effective Date;

"**The Savoy Theatre Shares**" means the 7,500 ordinary shares of 550p each in The Savoy Theatre Limited registered in the name of Newco at the Effective Date;

"**Stocks**" means, in respect of each of the Businesses, the stock in trade, work in progress, stocks and items owned by Newco in relation to that Business at the Effective Date; and

"**Transferees**" means Savreg A, The Berkeley, Claridges Holdings, The Connaught, The Lygon Arms, Theatre Holdings and SMS and "**Transferee**" shall mean any one of them.

1.2 In this Agreement, unless the context requires otherwise:-

1.2.1 headings are inserted for convenience only and do not effect its interpretation;

1.2.2 the Schedules form part of this Agreement and have the same force and effect as if expressly set out in the body of this Agreement and any reference to this Agreement shall include the Schedules;

- 1.2.3. words in the singular include the plural and vice versa and the masculine gender shall include the feminine and neuter;
  - 1.2.4. words and expressions defined in the Companies Acts 1985 to 1989 have the same meaning as in those Acts. and
  - 1.2.5 references to persons shall include individuals, bodies corporate, unincorporated associations and partnerships.
2. Subject to the provisions of this Agreement (including, without limitation, the proviso to this clause 2) on Completion:
  - (a) Newco shall transfer to Savreg A The Savoy Business as a going concern in consideration of the assumption and discharge by Savreg A of all Liabilities in respect of that Business, the allotment and issue by Savreg A to BHAC of such numbers of A Shares and to BRE/Satellite of such numbers of B Shares, in each case credited as fully paid, as are set out in Columns (3) and (4) of Schedule 2 and the crediting as fully paid of the 20 A Shares in the capital of Savreg A registered in the name of BHAC at the date of this Agreement;
  - (b) Newco shall transfer to The Berkeley The Berkeley Business as a going concern in consideration of the assumption and discharge by The Berkeley of all Liabilities in respect of that Business, the allotment and issue by The Berkeley to BHAC of such numbers of A Shares and to BRE/Satellite of such numbers of B Shares, in each case credited as fully paid, as are set out in Columns (3) and (4) of Schedule 2 and the crediting as fully paid of the 20 A Shares in the capital of The Berkeley registered in the name of BHAC at the date of this Agreement;
  - (c) Newco shall transfer to Claridges Holdings all of Newco's right and title to and interest in The Savoy Shares in consideration of the allotment and issue by Claridges Holdings to BHAC of such numbers of A Shares and to BRE/Satellite of such numbers of B Shares, in each case credited as fully paid, as are set out in Columns (3) and (4) of Schedule 2 and the crediting as fully paid of the 20 A Shares in the capital of Claridges Holdings registered in the name of BHAC at the date of this Agreement;
  - (d) Newco shall transfer to The Connaught The Connaught Business as a going concern in consideration of the assumption and discharge by The Connaught of all Liabilities in respect of that Business, the allotment and issue by The Connaught to BHAC of such numbers of A Shares and to BRE/Satellite of such numbers of B Shares, in each case credited as fully paid, as are set out in Columns (3) and (4) of Schedule 2 and the crediting as fully paid of the 20 A Shares in the capital of The Connaught registered in the name of BHAC at the date of this Agreement;
  - (e) Newco shall transfer to The Lygon Arms The Lygon Arms Business as a going concern in consideration of the assumption and discharge by The Lygon Arms of all Liabilities in respect of that Business, the allotment and issue by The Lygon Arms to BHAC of such numbers of A Shares and to BRE/Satellite of such numbers of B Shares, in each case credited as fully paid, as are set out in

Columns (3) and (4) of Schedule 2 and the crediting as fully paid of the 20 A Shares in the capital of The Lygon Arms registered in the name of BHAC at the date of this Agreement;

- (f) Newco shall transfer to Theatre Holdings all of Newco's right and title to and interest in The Savoy Theatre Shares in consideration of the allotment and issue by Theatre Holdings to BHAC of such numbers of A Shares and to BRE/Satellite of such numbers of B Shares, in each case credited as fully paid, as are set out in Columns (3) and (4) of Schedule 2 and the crediting as fully paid of the 20 A Shares in the capital of Theatre Holdings registered in the name of BHAC at the date of this Agreement; and
- (g) Newco shall transfer to SMS the Residual Businesses as a going concern in consideration of the assumption and discharge by SMS of all Residual Liabilities, the allotment and issue by SMS to BHAC of such numbers of A Shares and to BRE/Satellite of such numbers of B Shares, in each case credited as fully paid, as are set out in Columns (3) and (4) of Schedule 2 and the crediting as fully paid of the 20 A Shares in the capital of SMS registered in the name of BHAC at the date of this Agreement;

Provided that, in the case of each transfer referred to in sub-clauses 2(a), (b), (d), (e) and (g), the Stocks and the Prepayments relating to each of the Businesses referred to in such sub-clauses shall be sold in accordance with sub-cause 2(h) below;

- (h) Newco shall sell and each of the relevant Transferees shall purchase in respect of the Businesses being transferred to them respectively, such right, title and interests as Newco may have in the Stocks and Prepayments relating to such Business for a consideration equal to the book value of such Stocks and Prepayments in the books of account of Newco at the Effective Date, which consideration shall be satisfied by an appropriate part of the consideration referred to in each of sub-clauses 2(a), (b), (d), (e) and (g) above, as applicable.

- 3. The risk of loss or damage to the Business Assets and to the Stocks and Prepayments shall pass to the relevant Transferee with effect from the Effective Date.
- 4. Newco will make available to the relevant Transferee such of the Company Records as are in its possession at Completion on the following basis:
  - (a) the relevant Transferee will take receipt at Completion of those Company Records which relate solely to the Business being transferred to it (and SMS will take receipt at Completion of any Company Records which relate to two or more Businesses) and will store them, keeping them safe and in a reasonable condition for such period as Newco may reasonably require and initially for a minimum period of six (6) years. Newco and the Liquidators or their authorised representatives will be entitled during normal office hours to have access to the Company Records on the giving of reasonable notice and the relevant Transferee will provide facilities during normal office hours for the purposes of such inspection and Newco and the Liquidators may at their own expense copy any of the Company Records; and

- (b) a Transferee may at its own expense copy any Company Records which are in the possession of another Transferee.
5. The Businesses, the Shares and the Stock and Prepayments are transferred to the relevant Transferee subject to and with the benefit of all and any rights, restrictions, obligations, conditions and agreements affecting the same or any part thereof. Each of the Transferees hereby accepts without investigation such title as Newco may have to the Businesses, the Shares and the Stock and Prepayments and shall raise no objection or requisition in respect thereof.
6. Completion shall take place at the offices of Herbert Smith on the Effective Date. At Completion:-
- (a) Newco shall, at the cost of the relevant Transferee, execute all such documents and shall do all such acts and things as may reasonably be required by each of the Transferees to transfer such title as Newco may have to the relevant Shares and/or Businesses and/or Stocks and Prepayments to them respectively provided that a request for assistance pursuant to this clause is made before the earlier of six months from the Effective Date and the date on which the return is made to the Registrar of Companies pursuant to Section 94(3) of the Insolvency Act including, without limitation, executing in a form acceptable to the Liquidators forms of conveyance, transfer and/or assignment and doing such acts as are specified below:
- (i) delivering to the relevant Transferee all deeds and documents of title (if any) relating to the Business Premises relating to the relevant Business as are in the possession of Newco at the Effective Date;
- (ii) executing and delivering such documents as the Transferee may reasonably require to transfer such title as Newco may have at the Effective Date to each of the Business Premises relating to the relevant Business to the relevant Transferee;
- (iii) to the extent which it is able to do so, giving possession wherever they are situated of those Business Assets and Stocks agreed to be sold to the relevant Transferee in accordance with this Agreement which are capable of transfer by delivery (and, for the avoidance of doubt, title shall pass on such delivery);
- (iv) executing and delivering assignments of the Intellectual Property Rights associated with the relevant Business in the agreed form and all forms necessary to record the change of ownership thereof;
- (b) Newco shall let the relevant Transferee into possession of those assets which are not owned by Newco but which are used in the relevant Business (wherever they are situated) at the Effective Date;
- (c) the Transferees shall credit as fully paid the 20 A Shares in their respective share capitals registered in the name of BHAC and shall allot and issue the number of A Shares to BHAC and B Shares to BRE/Satellite in their respective share capitals as set out in Schedule 2 and shall make the

appropriate entries in their respective books in respect of such allotments and issues and shall deliver the share certificates in respect of such shares to BHAC and BRE/Satellite.

7.

- 7.1 BHAC hereby agrees to indemnify and shall keep indemnified Newco at all times against all Liabilities which are due from or required to be discharged by Newco.
- 7.2 Without prejudice to clause 7.1, each of the Transferees (other than SMS) shall assume, perform, satisfy and discharge all the Liabilities arising out of or in connection with the relevant Business or the Shares being transferred to them respectively and shall assume the obligations of and become entitled to the benefits of Newco under the Contracts relating to the Business and hereby agrees to indemnify and shall keep indemnified Newco at all times against all Liabilities relating to that Business (including without limitation the giving of possession to the relevant Transferee of the items referred to in clause 6(b)) or the Shares including, without limitation, those arising in respect of any failure on the part of Newco to perform any obligations under the Contracts. SMS shall assume, perform, satisfy and discharge all Residual Liabilities and shall assume the obligations of and become entitled to the benefits of Newco under the Contracts relating to the Residual Businesses and hereby agrees to indemnify and shall keep indemnified Newco at all times against all Residual Liabilities (including without limitation the giving of possession to the relevant Transferee of the items referred to in clause 6 (b)).
- 7.3 Where Newco is entitled to make a claim under clauses 7.1 and 7.2 of this Agreement, it shall first make a claim under the clause 7.1 before making a claim under 7.2. If the relevant Transferee does not pay and discharge in full any claim made under 7.1 within five Business Days of being notified of such a claim, Newco shall be entitled to make a claim under clause 7.2. Until such time as a claim made pursuant to clause 7.1 or 7.2 has been satisfied and discharged in full, the liability of each of the relevant Transferee and BHAC shall be joint and several.
- 7.4 Each of the Transferees shall, jointly and severally with the other Transferees, on the relevant transfers taking place pursuant to clause 2, indemnify The Savoy in respect of all obligations and liabilities of The Savoy which were or are assumed by or the subject of an indemnity from Newco pursuant to clauses 2.1 and 2.2 (but subject always to clause 2.3) of the Distribution and Transfer Agreement and shall indemnify and keep indemnified The Savoy in respect of all damages, costs, claims, expenses and other liabilities howsoever arising suffered or incurred by The Savoy as a result of a breach of its obligations under this clause, provided that no claim may be made under the indemnity given by the Transferees in this sub-clause 7.4 except in the event that The Savoy is unable to satisfy any liability the subject of such indemnity as a consequence of The Savoy being unable to pay its debts (within the meaning of Section 123 of the Insolvency Act).

- 7.5 The obligations and liabilities assumed by each Transferee in connection with the relevant Business shall, for the avoidance of doubt, include all obligations and liabilities of Newco in connection with the Employees of each of the Businesses. It is acknowledged by each of the Transferees that the transfer of the relevant Business pursuant to this Agreement, including the relevant Business Assets, constitutes a "relevant transfer" for the purposes of the Transfer of Undertakings (Protection of Employment) Regulations 1981. In accordance with, and pursuant to provisions of such Regulations, the Employees of each of the relevant Businesses shall become employees of the relevant Transferee with effect from the Effective Date. The relevant Transferee shall notify the Employees of each Business of the transfer as soon as practicable after the Effective Date.
  - 7.6 The Transferees shall from the Effective Date assume responsibility as the employers of the Employees for their own account from the Effective Date and shall assume all liabilities relating to or connected with the Employees and the relevant Transferee (that is the Transferee to whom an Employee transfers) shall indemnify Newco against all such liabilities.
  - 7.7 If any contract of employment of an Employee does not have effect as if originally made between a Transferee and that person, or it is alleged not to have that effect, Newco will nominate a Transferee as the entity that it believes is the proper employer of the Employee and that Transferee will, within 14 days of a notification by Newco, offer to employ him under a new contract subject to, and to take effect on, the termination which has occurred or as referred to below (as the case may be). On that offer being made, or at any time after the expiry of 14 days if the offer is not made as requested, Newco will terminate the employment of the person concerned. The relevant Transferee shall indemnify Newco against any liabilities arising out of such termination and against any sum payable to or in respect of that employee in respect of his employment following the Effective Date.
8. For the avoidance of doubt, it is hereby agreed that the Liquidators are entering into this Agreement solely in their capacity as Liquidators of Newco and, accordingly, they shall only be obliged to perform any obligations hereunder to the extent they are able to do so in such capacity and shall incur no personal liability of any kind under, or by virtue of, this Agreement or in relation to any related matter or claim whether in contract, tort or restitution or by reference to any other remedy or right, in any jurisdiction or forum.
  9. The Liquidators have joined in as parties to this Agreement solely for the purpose of obtaining the benefit of clauses 8, 9, 10 and 11 and any other provisions of this Agreement in their favour.
  10. Without prejudice to clause 8, the Liquidators shall not be liable on any deed or document executed with a view to, or for the purposes of, giving effect to this Agreement whether or not that deed or document so provides in its terms and the Liquidators shall be entitled at any time to have such deed or document amended so as to exclude personal liability in the terms of clause 8.

11. For the purpose of any acknowledgements or agreements as to, or provisions of, exclusions of liability or indemnity in favour of the Liquidators in this Agreement, references to "the Liquidators" where the context so permits shall mean and include their present and future firm or firms, partners and employees and any legal entity or partnership using in its name the words "Deloitte & Touche" and the partners, shareholders, officers and employees of any such entity or partnership or any person who, properly, at the request of or under the direction of the Liquidators becomes engaged in the conduct of the winding up.
12. Any notice or demand to be served under this Agreement shall be served upon a party at the address given above or, in the case of notices or demands served by fax, to the fax number notified by any party to the others for the purpose of this clause or such other address as may have been notified to the other parties as being its address for service or the last known place of business. Any notice shall be served personally or by pre-paid first class post or by facsimile transmission. A notice or demand served personally shall be deemed to have been served at the time of delivery, a notice or demand served by post shall be deemed duly served 48 hours after posting and a notice or demand sent by facsimile transmission shall be deemed to have been served at the time of transmission and, in proving service of the same, it will be sufficient to prove that delivery was made or that the envelope containing such notice or demand was properly stamped, addressed and placed in the post and, in the case of a facsimile transmission, that such facsimile was duly transmitted to the correct facsimile number.
13. So far as it remains to be performed, this Agreement shall continue in full force and effect notwithstanding Completion.
14. This Agreement and the transactions contemplated by it shall be governed by and construed in accordance with English law and the parties hereto irrevocably submit to the non-exclusive jurisdiction of the English courts.
15. This Agreement may be executed in two or more counterpart copies each of which will be deemed to be an original and all of which taken together will constitute one and the same document.
