The company's immediate parent undertaking is Chem-Dry UK Limited, a company registered in Great Britain. Independent Group (UK) Limited, a company registered in Great Britain, is the ultimate holding company within the Group. In April 2016, 75% of the share capital of the ultimate holding company, Independent Group (UK) Limited, was acquired by the private equity firm Rcapital Limited.
