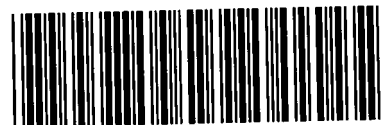


Directors Responsibilities



1. Company Status
