To undertake the management of and purchase, take on lease, exchange, lease or otherwise deal in and hold for the purpose of development, investment or resale and to traffic in any freehold, leasehold or other property for any estate or interest whatever, and to create, reserve, sell and deal in freehold and leasehold ground rents, and to make advances upon the security of land or house or other property or any interest therein, and whether erected or in course of erection, and whether on first mortgage or subject to a prior mortgage or mortgages, and to carry on all or any of the businesses of property managers and consultants, business consultants and advisers, proprietors and operators of commercial and industrial agencies, building and civil engineering contractors, land estate and property developers, repairers and agents, surveyors, valuers and auctioneers, builders' merchants, factors, designers, assemblers, importers, exporters, repairers, installers, maintainers, hirers, letters on hire, distributors and agents for the sale of and dealers in capital equipment and plant machinery, components, accessories, tools and fixtures of all kinds, merchants haulage and transport contractors, electricians and general engineers and to carry on any other trade or business whether subsidiary or not which can in the opinion of the Company be carried on advantageously in connection with any of the trades or businesses. aforesaid or which in the opinion of the Company will enhance the value

of any of the Company's property."

- (ii) re-numbering the existing sub-clauses 3.1 to 3.28 as 3.3 to 3.30.
