"Control" means the possession, directly or indirectly, of the power to direct or cause the direction of the management or policies of a person, whether through the ownership of voting securities, by contract or otherwise, and "Controlling" and "Controlled" have meanings correlative thereto,

"Copyright License" means any written agreement granting any right to the Company under any Copyright owned by any other person, and all rights of the Company under any such agreement (including any such rights that the Company has the right to license),

"Goods" means all things that are movable when a security interest attaches. "Security Documents" means the Mortgages, the Guarantee Agreement, the Collateral Agreement, the Foreign Pledge Agreements, the Foreign Security Documents, the Intellectual Property Security Agreements and each of the security agreements, mortgages and other instruments and documents executed and delivered pursuant to any of the foregoing or pursuant to the Credit Agreement, in each case, as amended from time to time in accordance with the terms of the Credit Agreement and the Collateral Agreement,

"Subsidiary" means a subsidiary of Intermediate Holdings other than any unrestricted subsidiary under the Credit Agreement,
