Principal activity, review of business and future developments

The principal activity of the Company was to act as the General Partner of the Lyceum Capital Fund 2000 English Limited Partnerships (the "Funds") managed by Horizon Capital LLP (formerly Lyceum Capital Partners LLP). These funds were liquidated during 2013. The company will be liquidated in due course.

The Directors who held office during the period are given below:-





a. Basis of preparation

The financial statements are prepared on the going concern basis, under the historical cost convention, and in accordance with the Companies Act 2006 and Accounting Standards applicable in the United Kingdom (United Kingdom Generally Accepted Accounting Practice).

The financial statements are presented in Euro, the primary and functional currency of operations for the Company as General Partner of the Funds.

b. Income

Income is recorded on an accruals basis.

The Company is a wholly-owned subsidiary of Horizon Capital LLP. The Company has not prepared a cashflow statement as it has taken advantage of the exemption from preparation under the terms of FRS102.
