

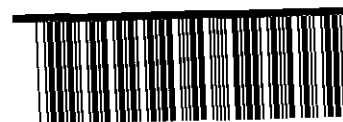

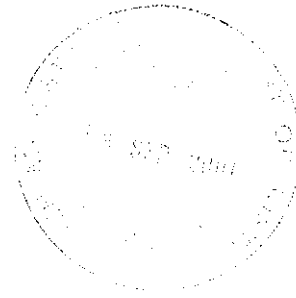

**ORDER**

**UPON THE PETITION** of Stephen Christian Wegerif of Whitemoors Farm, Main Street, Shenton, Nuneaton, Warwickshire, CV13 6BZ, Dexter Michael Dimblebee of Jasmine House, 45 High Street, Lutterworth, Leicestershire, LE17 4AY, Dhiraj Varia of 126 Ross Walk, Leicester, Leicestershire, LE4 5HH and Matthew Bryan Dannfald of 152 Charnwood Road, Barwell, Leicester, LE9 8FU the directors of the above-named company (referred to in this order as "the Company"), presented to the court on 7 September 2001

**AND UPON HEARING** Counsels for the Petitioners

**AND UPON READING** the evidence

1     **IT IS ORDERED** that during the period for which this order is in force the affairs business and property of the Company be managed by the administrators appointed by this order pursuant to the provisions of Section 8 of the Insolvency Act 1986 for the following purposes:-

1.1     the survival of the Company and the whole or any part of its undertaking, as a going concern

- 1.2 A more advantageous realisation of the Company's assets than would be effected on a winding-up.
- 1.3 the approval of a voluntary arrangement under Part I of the Insolvency Act 1986.
- 2 **AND IT IS ORDERED** that Kirankumar Mistry a licensed insolvency practitioner of Messrs HKM Harlow Khandhia Mistry of The Old Mill, 9 Soar Lane, Leicester, LE3 5DE and Paul Anthony Saxton a licensed insolvency practitioner of Messrs Elwell Watchorn Saxton of 109 Swan Street, Sileby, Loughborough, Leicester, LE12 7NN be appointed joint administrators of the Company.
- 3 **AND IT IS ORDERED** that the costs of the Petitioners and the report prepared pursuant to Rule 2.2 of the Insolvency Rules 1986 be afforded the priority provided by Section 19(5) of the Insolvency Act 1986.
- 4 **AND IT IS ORDERED** that pursuant to Section 231 of the Insolvency Act 1986 any act required or authorised to be done by both administrators may be exercised by each of the administrators independently of the other.
- 5 **AND IT IS ORDERED** that pursuant to Rule 12.9 of the Insolvency Act 1986 the time for service of the petition under Rule 2.7 upon the joint administrators, Lloyds TSB Bank Plc and the Company be abridged.
- 6 **AND IT IS ORDERED** that the matter be re-listed for mention and/or further application on Monday 19 November 2001
