NOTES TO THE ABBREVIATED ACCOUNTS

FOR THE YEAR ENDED 31 MARCH 2014

1 Accounting policies

1.1 Accounting convention

The financial statements are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

The directors are of the opinion that the company's project will produce income sufficient to eliminate the adverse balance on the profit and loss account. The company also benefits from ongoing support from other group undertakings. In these circumstances, the financial statements have been prepared on a going concern basis.

1.2 Compliance with accounting standards

The financial statements are prepared in accordance with applicable United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice), which have been applied consistently (except as otherwise stated).

1.3 Turnover

Turnover represents amounts receivable for goods and services net of VAT and trade discounts.

1.4 Leasing

Rentals payable under operating leases are charged against income on a straight line basis over the lease term.

1.5 Stock and work in progress

Work in progress, other than long-term contract work in progress, is stated at the lower of cost and net realisable value.

Long-term contract work in progress is stated at cost, plus attributable profits, less provision for known losses and payments on account received and receivable. The amount recorded as turnover in respect of long term contracts is ascertained by reference to the value of work carried out to date. Attributable profit is recognised as the difference between record turnover and related costs. Interest on loans in relation to the project is written off to the profit and loss account in the year in which it is incurred.

1.6 Rental Income

Rental Income from operating leases is recognised on a straight line basis over the term of the lease
