### NOTES TO THE ABBREIVATED FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2005

### 1. ACCOUNTING POLICIES

### Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective March 2000).

### **Grant Income**

Grant income represents the amount of grant income pledged.

### Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Office equipment - 33 1/3% on cost
Fixtures and fittings - 33 1/3% on cost
Office furniture - 33 1/3% on cost
Computer equipment - 50% on cost

### **Deferred** taxation

Provision is made at current rates for taxation deferred in respect of all material timing differences except to the extent that, in the opinion of the directors, there is reasonable probability that the liability will not arise in the foreseeable future.

### Membership income

Membership fees represent subscriptions invoiced, net of Value Added Tax.

### Other income

Other income represents the amounts invoiced for services provided and conference income, net of Value Added Tax.
