### TRUSTEES' REPORT FOR THE YEAR ENDED 31 MARCH 2015

The Trustees (who are also directors of the charity for the purposes of the Companies Act) present their annual report together with the financial statements of Told By An Idiot (the charity) for the year ended 31 March 2015. The Trustees confirm that the Annual report and financial statements of the charity comply with the current statutory requirements, the requirements of the charity's governing document and the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" issued in March 2005.

### Structure, governance and management

### a. CONSTITUTION

The charity was incorporated on 10 June 1999 as a company limited by guarantee and is governed by its Memorandum and Articles of Association as amended by Special Resolution on 21 July 2009. The company was registered as a charity by the Charity Commission in England and Wales on 14 May 2001. The object for which the charity was established is to advance education for the public benefit by the promotion of the arts, in particular but not exclusively the art of drama.

### **b. RECRUITMENT AND APPOINTMENT OF TRUSTEES**

The management of the company is the responsibility of the Trustees, who are appointed under the terms of the Articles of Association. The Trustees shall be no less than three and no more than seven. All members of the Board of Directors who have served for three years from the date of their election must retire. Having retired, a trustee can offer himself/herself for re-election provided he/she has served for a period of less than six years. A Trustee who has served six years must retire at the AGM, which takes place at the end of his/her sixth year and shall not be eligible for re-election to the Board of Directors for at least one year. New Trustees are proposed by serving Trustees or the company's executive team and elected with a majority vote by the Trustees.

### c. INDUCTION AND TRAINING OF TRUSTEES

An induction process has been established for new Trustees. Separate meetings are arranged with the Chair and executive team. In addition Trustees are presented with a welcome pack, including Charity Commission guidelines, a list of board roles and responsibilities, the company business plan, company handbook and Memorandum and Articles of Association. Trustees are also offered the opportunity to attend Independent Theatre Council training for board development.

### d. ORGANISATIONAL STRUCTURE

An Artistic Director (part-time), an Executive Producer (full-time), an Assistant Producer (part-time), a Participation Manager (part-time), and a Finance Manager (freelance) manage the everyday operations of the company. The executive team, made up of the Artistic Director and the Executive Producer, reports to the Trustees at quarterly board meetings. The Finance Manager acted as Company Secretary to the board until his retirement on 26 March 2015 following which the Executive Producer took on that role..

### e. RELATED PARTIES

The Chair of Trustees, Andrew Comben, is Chief Executive of Brighton Dome and Festival Ltd with which the company has worked with in 2011/12. Trustee Louise Jeffreys is Director of Programming at the Barbican Centre with which the company has worked in 2012/13. Trustee Jacqui O'Hanlon is Director of Education at the Royal Shakespeare Company with which the company has worked in 2010/11.

### f. RISK MANAGEMENT

The Trustees have assessed the major risks to which the charity is exposed, in particular those related to the operations and finances of the charity, and are satisfied that systems and procedures are in place to mitigate our exposure to the major risks.

### **Objectives and Activities**

### a. PUBLIC BENEFIT

The principal activities of the company during the year continued to be theatrical productions, projects, artist development and education/participation.

When planning activities, the trustees have considered the Charity Commission's guidance on public benefit and fee-charging. Grants and funding contributions form the company's main source of income, which is supplemented by box office receipts. The charity makes every effort to ensure that ticket prices for performances allow access to the company's work by members of the public on low incomes.

### **b. SIGNIFICANT ACTIVITIES**

The company's mission statement is as follows:

Told by an Idiot creates theatre for national and international touring and for specific spaces. We set out to explore the human condition by celebrating and revelling in a style of theatre that is bigger than life. The company will always seek to acknowledge the artifice of theatre and make no attempt to put reality on stage. We remain, however, fascinated by the fine line between comedy and tragedy that exists in the real world. Through collaborative writing, anarchic physicality and a playful but rigorous approach to text, the company is committed to creating a genuinely spontaneous experience for the audience. Using a wealth of imagery and a rich theatrical language, we aim to tell universal stories that are accessible to all.

The aims of the company are:

- To produce an exciting and stimulating theatrical experience
- To engage with a wide cross-section of audiences in a variety of stories, using a wealth of imagery and a rich theatrical language
- To collaborate with high quality artists, both within theatre and across artforms
- To celebrate the diversity of cultures in our society by presenting work by and with artists of different cultural backgrounds
- To engage young audiences in the theatre experience
- To promote British theatre on an international platform
- To produce work from a sound financial and administrative base
- To inspire and encourage the next generation of theatre-makers

### Achievements and performance

### a. REVIEW OF ACTIVITIES

During 2014/15 we continued to produce challenging, enjoyable productions and participation events of quality around the country, ensuring artistic excellence is thriving and celebrated on a variety of levels.

In 2014/15 we made a strategic and demand-led decision to re-mount 2 of our productions; 5 star My Perfect Mind and comedy Never Try This At Home. The latter played at the Latitude Festival in Suffolk and My Perfect Mind was seen by a further 7,300 people, playing for another 10 weeks. This included showcasing the production in Spain, highlighting to a European audience the strength and excellence of British work. From this important remount the show was confirmed to perform in New York in June 2015, further allowing our work to be celebrated as excellent, in-demand, high quality British theatre.

The quality and excellence of our work was marked out by audience and venue demand. We succeeded in achieving 2 sold out shows in Barcelona, a further 4 week run at the Young Vic (following on from 5 weeks in 2013/14), and an almost full house in the theatre tent at the Latitude Festival which was a huge achievement given that audiences can absolutely vote on their feet in such a festival environment given the myriad of other cultural activities happening at the same time.

## TRUSTEES' REPORT (continued) FOR THE YEAR ENDED 31 MARCH 2015

Overall we delivered a total of 13 performance weeks across 2014/15, not including our Taught programme of work. We offered 14,305 tickets to our productions with an actual reach of 9,579 ticket bookers, representing a 67% capacity over the year. Our performances were staged across 9 different local authority areas emphasising a good geographic spread of activity and, given our flexible producing model, we were able to engage on a variety of scales through-out the year; mid-scale touring, festival performing, international showcasing, and small, bespoke events with varieties of age groups through Taught.

### **Never Try This At Home**

The majority of this production ran in 2013/14 however there were 3.5 additional playing weeks that fell into April 2014. We continued to have great audience responses and were subsequently invited to play at the Latitude Festival in Suffolk in July 2014, highlighting that our unique, innovative and experimental style of theatre is highly valued by audiences and the industry. Our performance at the Latitude Festival exposed us to a new, family and festival-going audience who thoroughly enjoyed the show. From the final weeks at Soho to the Latitude Festival performance the show was seen by a further combined figure of 2,323 more people in 2014/15, receiving great audience comments again such as "Fantastic / I laughed from start to finish".

### My Perfect Mind

in 2014/15 we made a strategic decision to exploit the initial investment in My Perfect Mind and re-mount the production in 2014/15 to deliver a much wider UK tour. On its initial outing in 2012/13 the show reached 7,237 but in 2014/15 we managed to share the production with a further 7,356, including 4 new venues and 2 repeat visits due to demand. We also took the production to Barcelona for 2 sold out performances, reaching 804 people and making a strong link to a new European venue. We toured to UK venues including West Yorkshire Playhouse, the Tobacco Factory in Bristol, Unity Theatre in Liverpool, Birmingham Repertory Theatre and the Stephen Joseph Theatre in Scarborough. The show was again critically recognised through local and national press acclaim, receiving 5 stars in the Telegraph and 4 stars in The Times, with The Times quoting "My Perfect Mind was created by a devising process that makes it lively and fluid... there's nothing quite like it".

### Taught by an Idiot (Taught)

Taught lies at the heart of the company's identity and is a major interactive initiative set up as a direct response to creating performance and participation activity that is anarchic, spontaneous and accessible to the widest possible audience. Offering a range of events from Workshops to performances, post show improvisations to professional development and long term residencies to spontaneous happenings, the company's Taught work is fundamentally about collaboration, liberation and the pursuit of pleasure. The only thing asked is that participants of Taught have a sense of openness, curiosity and the desire to play.

In 2014/15 we again held diverse range of Taught activity, emphasising our continued commitment to growing this area of the company ever further. Most importantly in this year we employed a Participation Manager for the first time in the company's history; a part-time role (2 days a week) dedicated to furthering this arm of the company, seeking out opportunity as well as responding to enquiries through-out the year; many of which were previously difficult to fulfil due to a clear staff shortage in this area.

In 2014/15, through our Taught activity, we delivered 27 learning and participation Workshops and activities (41 sessions in total) and reached a total of 695 attendees - almost double the number reached last year. We have also been able to deliver Workshops for groups in Key Stages 3, 4 and 5 for the first time and this activity has seen us engaging with schools, community groups and youth groups across the UK that we have not worked with previously.

## TRUSTEES' REPORT (continued) FOR THE YEAR ENDED 31 MARCH 2015

### A further snapshot includes:

- · working with writers' groups in Hull
- budding 'clowns' in a school in Essex
- a Fun Palace event in a deprived area of our local borough of Camden
- bringing together an elderly group from Coventry and a group of young teenage migrants and refugees in Kilburn to digitally devise across the miles
- using our creative techniques with deaf actors in London
- directing improvisation with young directors as part of the JMK award
- informing opera singers at ENO of our style of theatre.

74% of survey respondents from our Taught Artist Development Workshops were under 34 years old, emphasising our success in this area for supporting young emerging talent, and 14% of those that attended these Workshops acknowledged themselves as having a disability which is a huge development from last years' statistic and something we have worked hard on in 2014/15. We continue to maintain, and better, our reputation for providing inclusive and accessible opportunities for all.

Our 'Role of the Director in the Devising Process' annual week-long Workshop sold out again for the 3rd year running attracting 20 diverse participants and in 2014/15 we also trialled a new season of Workshops for emerging artists entitled 'The Passion of the Idiot' focussing on how we create our work. We will replicate this season again next year.

Feedback from artists regarding Workshops continues to be very strong with comments including: "It was exceptional. Paul is an absolute luminary. This was the most enlightening, liberating, inspiring Workshop I've ever done" I "The Workshop exceeded my expectations, which were pretty high already - I feel like I've grown a foot or two" I "An incredible opportunity to learn from the experience and hard won knowledge of a brilliantly innovative company".

Under Taught we also encouraged the skilling-up and diversification of the arts workforce through an apprenticeship and a traineeship, both participants being either unemployed or without formal secondary education grades.

We continued in our relationship with Royal Academy of Dramatic Art, being now resident in their RADA Studios building and enjoying a continuing deeper relationship with their students and staff as Creative Associates. Although still a relatively new relationship, in this financial year, as well as delivering talks to the students, we worked with them to create our first Radio Play which was offered for free on social media & Soundcloud, and conducted Workshops for the RADA Youth Company with feedback including "This was perfect!" and "Loved it. Cannot recommend these Workshops more".

### Research and Development (R&D)

Alongside reviving 2 shows we remained dedicated to rigorous R&D of new ideas. We engaged in ongoing development of a commission for 2016, R&D'ed a completely new idea and experimented with the medium of radio. To ensue excellence in the process we not only invited RADA students to work with us to ensure our work is questioned and provoked by a variety of sources / generations, we also collaborated on R&D's with experiences and diverse artists, companies and venues. We worked with Greek-Cypriot film actor Miltos Yerolemou and again with acclaimed director Kathryn Hunter on a new idea for 2017. We worked with Sony award-winning BBC radio director/producer Jeremy Mortimer for our radio project and Cirque del Soleil performer Joanna Holden for the R&D of our 2015 production, The Ghost Train. The R&D's also continued to provide useful opportunities to meet venue partners face to face and to receive feedback on material from a variety of influences and professions. R&D's allow us to work with a wide pool of actors and emerging talent, giving opportunities to Assistant Directors in particular. Our diverse work within our R&D environment in 2014/15 highlights perfectly our ongoing curiosity and refusal to settle.

## TRUSTEES' REPORT (continued) FOR THE YEAR ENDED 31 MARCH 2015

### **b. FUNDRAISING ACTIVITIES**

In 2014/15 we made successful headway into strategizing our long term financial sustainability. Through detailed board consultation we employed a fundraising consultant who delivered a comprehensive Fundraising Review. Delivered in January 2015 and with short and long term objectives we will continue to work through the action points across 2015/16 but, in the short time between January and March in 2014/15 managed to submit 10 new Trust and Foundation applications for Taught activity, 3 of which were successful and raised £12,000 for forthcoming activity – almost doubling our fundraised figure in 2013/14 highlighting a successful upward trend.

Our membership scheme continues to gather strength and new members from launching in late 2013/14 with 4 members to ending 2014/15 with 23 members. And finally, our investment in a dedicated Taught Participation Manager also saw this contributed income stream strengthen for the company, reaching 88% of income target for the year and over doubling it from 2013/14.

### Financial review

### a. RESERVES POLICY

It is the trustees' policy to hold a sum equal to three months administration and overheads costs as a reserve. The Trustees consider that this sum is sufficient to ensure the company can meet financial obligations.

### **b. FUNDS AT 31 MARCH 2015**

The carried forward surplus as at 31 March 2015 is £118,459 of which £38,366 comprises the reserve above, based on the budgeted administration and overhead costs for 2015-16. Of the remaining balance of £80,093, there are restricted funds of £4,237 and designated funds of £25,918: £10,006 for a fundraising consultant; £1,212 for the development of Taught, £5,700 for Taught's participation manager and £3,000 for digital development. There is a wholly unrestricted reserve of £49,938 available to cover unfunded production costs and contingencies.

### c. PRINCIPAL FUNDING SOURCES

Told by an Idiot continues to be revenue funded by Arts Council England as a National Portfolio organisation (NPO) and was successful in the open application process for funding as a National Portfolio Organisation until March 2018. The company also works in financial partnership with other organisations/venues to create its productions and relies on Trusts and Foundations funding for the majority of its Taught projects.

### INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF TOLD BY AN IDIOT

I report on the financial statements of the charity for the year ended 31 March 2015 which are set out on pages 11 to 23.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2015

### 1. ACCOUNTING POLICIES

### 1.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention. The financial statements have been prepared in accordance with the Statement of Recommended Practice (SORP), 'Accounting and Reporting by Charities' published in March 2005, applicable accounting standards and the Companies Act 2006.

### 1.2 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes.

Designated funds comprise unrestricted funds that have been set aside by the Trustees for particular purposes. The aim and use of each designated fund is set out in the notes to the financial statements.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes. The costs of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

### 1.3 Incoming resources

All incoming resources are included in the Statement of financial activities when the charity has entitlement to the funds, certainty of receipt and the amount can be measured with sufficient reliability.

Grants are recognised in the year in which they are received, except:

- when funders specify that grants should be spent in future accounting periods, that income is deferred until those periods.
- when funders impose conditions to be fulfilled before the charity becomes entitled to use grants, that income is deferred until the preconditions are met.

### 1.4 Resources expended

Expenditure is accounted for on an accruals basis and has been included under expense categories that aggregate all costs for allocation to activities. Where costs cannot be directly attributed to particular activities they have been allocated on a basis consistent with the use of the resources.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2015

### 1. ACCOUNTING POLICIES (continued)

### 1.5 Tangible fixed assets and depreciation

All assets costing more than £500 are capitalised.

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

Fixtures and fittings

Straight line over three years

### 1.6 Taxation

The charity is exempt from corporation tax in respect of income to the extent that such income is applied exclusively to charitable purposes.

### 1.7 Pensions

The charity contributes to personal pension plans and the pension charge represents the amounts payable by the charity to the fund in respect of the year.

### 18. NATURE AND PURPOSE OF FUNDS

### Research and development

Contributions from co-producers have been applied to research and development of new productions and projects together with funding from the charity's unrestricted general funds.

#### Website

Unrestricted general funds were set aside in the previous year to enable the charity's website to be viewed satisfactorily on all internet-capable devices and to be updated to represent the charity for 2013 and beyond. Further amounts have been set aside for ongoing technological development over the next four years.

### **Fundraising**

Following the deferral of the strategy to employ a fundraising consultant further unrestricted general funds have been set aside for a five-year strategy.

### **Taught By An Idiot**

An unrestricted designated fund has been created from general funds to increase the participation manager's role and for the development of materials for the project.

### General fund

The trustees' policy is to maintain a sum at least equal to three months' budgeted administration and overhead costs as a reserve.

### **Taught By An Idiot: Connect**

Funds were raised specifically for the Connect project, being part of the Taught By An Idiot programme starting in April 2014.

### The Garrick Trust

The Garrick Charitable Trust provided funds which have been spent on additional creative costs on the production, Get Happy.
