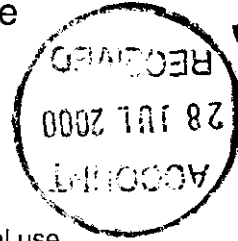

Short particulars of all property mortgaged or charged
