**UPON THE APPLICATION** by claim form dated 12 September 2012 of Thurnham Vacation Club Management Limited ("**Company**") whose registered office is at Citrus House, Caton Road, Lancaster, Lancashire, LA1 3UA

**AND UPON HEARING** counsel for the Company

**AND UPON READING** the claim form and the evidence

**IT IS ORDERED** that the Company have permission to convene a meeting of its sole shareholder ("**Meeting**") for the purpose of considering and if thought fit approving with or without modification the draft terms of merger in relation to the proposed cross-border merger between the Company and Octopus Liegenschaftsverwaltungsgesellschaft m.b H.
