# Advertising Education Forum Limited Report of the Directors

The directors have pleasure in presenting their report and financial statements for the year to 31 December 2011

#### Principal activity and business review

The principal activity of the company throughout the year was as a membership organisation acting as an authoritative and respected source of information and centre for research on the issue of advertising and children, and to contribute to an informed debate on that issue

During 2011 AEF data sources and opinions were extensively used by governmental bodies, NGO's, academics and other interested parties

#### Results

Although the general economic situation continues to be difficult there were no member resignations in the year. However in spite of the efforts to increase the membership this has not happened and there remain ten members. A deficit after taxation of £1,385 has resulted decreasing the revenue reserves to £13,642 (2010 -£15,027). However the deficit for the year included a large profit on exchange of £1,972 reflecting the increasing strength of the pound against the euro in the latter part of the year.

The directors who served the company throughout the year were Alessandro Cagli David Coleman

#### Statement of Director's Responsibilities

#### 1 Limited Liability

Advertising Education Forum is a company limited by guarantee. The Memorandum of Association restricts the liability of members on winding up to  $\pounds 1$  unless their liability becomes unlimited through contravention of the Memorandum

#### 2. Principal Accounting Policies

#### (a) Accounting basis and standards

The financial statements have been prepared under the historical cost convention and in accordance with applicable Accounting Standards and the Financial Reporting Standard for Smaller Entities (effective April 2008) These accounting policies have remained unchanged since the previous year

#### (b) Income

Income represents membership subscriptions for the year receivable from members. These subscriptions are credited to the income and expenditure account on the basis of the financial year to which they relate. Subscription income attributable to the next financial year (2012), or invoiced in respect of it, is shown as deferred income

#### (c) Exchange Differences

Transactions denominated in foreign currencies are translated into sterling at the rate of exchange ruling at the date of the transaction. Assets and liabilities in foreign currencies are translated into sterling at the rates of exchange ruling at the end of the financial year. All exchange differences are dealt with in the income and expenditure account.
