### **PARTIES**

- (1) M3 COMMUNICATIONS LIMITED (company number 03810444) incorporated and registered in England and Wales whose registered office is at James House, Newport Road, Albrighton, WV7 3HA ("the Company").
- (2) PAUL ANDRE SHAW of Primrose Cottage, Hatfield Bank, Norton, Worcester, WR5 2PZ ("the Seller").
- (3) DAVID LAWRENCE of 15 Meadow Road, Finchfield, Wolverhampton, WV3 8EZ and JONATHAN PAUL FOWLE of 61 Milner Road, Birmingham, B29 7RL (the" Continuing Shareholders").

#### INTRODUCTION

- (A) The Company is a private company limited by shares incorporated in England on 20 July 1999 under the Companies Act 1985.
- (B) The Company has an authorised share capital of £50,000 divided into 100,000 ordinary shares of 50p each.
- (C) The Company has an issued share capital of 9,625 "A" ordinary shares of 50p each, 4,529 "B" ordinary shares of 50p each and 7,020 "C" ordinary shares of 50p each.
- (D) The Seller is the registered holder and beneficial owner of 7,020 "C" ordinary shares of 50p each in the capital of the Company ("Shares").
- (E) The Company wishes to purchase the Shares pursuant to the power conferred in section 162 of the Companies Act 1985 (the "Act") and the Seller has agreed to sell his Shares for £50,000 (the "Consideration") and terms specified in this agreement.
- (F) The terms of this agreement were authorised in connection with section 164(2) of the Act by a special resolution of the Company passed on the date of this Agreement.

#### IT IS AGREED as follows:-

### 1 Definitions and Interpretation

- 1.1 In this agreement the following words and expressions shall have the following meanings:
  - "Compromise Agreement" means the compromise agreement between the Company and the Seller in the agreed form.
  - "Encumbrance" means any interest, right, claim or equity of any person (including any right to acquire, option or right of pre-emption and any right to occupy or make use of the Property or any part of it) or any mortgage, charge, pledge, lien, assignment (including assignment for the purpose of security), security interest or security arrangement, easement or quasi-easement, licence, or any encumbrance

of any kind whatsoever (including any of the same arising by operation of law or equity) or any agreement (whether conditional or otherwise) to create any of the same.

**"FCA"** means Foster Care Association or any body or organisation directly or indirectly associated with them.

**"Loan Agreement"** means the loan agreement between the Seller, the Company and David Lawrence in the agreed form.

"Security Interest" means any mortgage, charge, assignment or assignation by way of security, guarantee, indemnity, debenture, hypothecation, pledge, declaration of trust, lien, right of set off or combination of accounts or any encumbrance or security interest whatsoever, howsoever created or arising and whether monetary or not.

"Seller's Solicitors" means Harrison Clark LLP of 5, Deansway, Worcester, WR1 2JG.

"Warranties" means the warranties set out in clause 4.

- Any reference to a statute, statutory provision or subordinate legislation shall be construed as referring to that statute, statutory provision or subordinate legislation as amended, modified, consolidated, re-enacted or replaced and in force from time to time, whether before or after the date of this agreement and shall also be construed as referring to any previous statute, statutory provision or subordinate legislation amended, modified, consolidated, re-enacted or replaced by such statute, statutory provision or subordinate legislation.
- 1.3 Any reference to a statutory provision shall be construed as including references to all statutory instruments, orders, regulations or other subordinate legislation made pursuant to that statutory provision.
- 1.4 Unless the context otherwise requires, all words and expressions which are defined in the Companies Act 1985 shall have the same meanings in this agreement.
- 1.5 Unless the context otherwise requires:
  - 1.5.1 words denoting any gender include all other genders;
  - 1.5.2 any reference to "persons" includes individuals, bodies corporate, companies, partnerships, unincorporated associations, firms, trusts and all other legal entities;
  - 1.5.3 any reference to a party is to a party to this agreement.
- 1.6 Clause headings are for convenience only and shall not affect the interpretation of this agreement. Any reference to a clause, sub-clause, paragraph or schedule is to the relevant clause, sub-clause, paragraph or schedule of this agreement.
- 1.7 The schedules to this agreement shall for all purposes form part of this agreement.
- 1.8 Any reference to a document being in the "agreed form" means a document in a form agreed by the parties and initialled by, or on behalf of, each of them for the purposes of identification.

1.9 Any phrase introduced by the terms "including", "include", "in particular" or any similar expression shall be construed as illustrative and shall not limit the sense of the words preceding those terms.

## 2 Sale and purchase of shares

- .2.1 On the terms of this agreement, the Seller shall sell and the Company shall buy the Shares with full title guarantee, free from all liens, charges, Encumbrances and any Security Interest together with all benefits and rights that attach (or may in the future attach) to the Shares.
- 2.2 The Seller and the Continuing Shareholders severally waive any rights of preemption or other restriction on the transfer of the Shares or any of them conferred by the articles of association of the Company or otherwise and have procured the irrevocable waiver of such right of restriction conferred on any other person who is not a party to this agreement.

## 3 Completion

А

- 3.1 Completion of the sale and purchase of the Shares shall take place immediately on execution of this agreement at the offices of the Company, when the Seller shall:
  - 3.1.1 deliver the share certificate(s) or other evidence of title to the Shares to the Company;
  - 3.1.2 provide the waivers, consents and other documents required to enable the Buyer to be the registered holder of the Shares;
  - 3.1.3 deliver to the Company the duly executed original Compromise Agreement and Loan Agreement; and
  - 3:1.4 provide a written resignation, executed as a deed in the agreed form of the Seller as secretary and director of the Company.
- 3.2 The Company shall satisfy its obligation to pay the Consideration sum in respect of the Shares by payment of the sum of £50,000 by way of electronic transfer to the Seller's Solicitors at the following bank account: HSBC Bank plc, Broad Street, Worcester, sort code: 404717 Account No: 72348608 whose receipt shall be deemed to be receipt by the Seller.

#### 4 Warranties

- 4.1 The Seller warrants to the Company that each Warranty is true and accurate and not misleading in any material respect as at the date of this agreement.
- 4.2 Each Warranty shall be construed as a separate and independent warranty and, except where expressly stated, shall not be limited or restricted by reference to or inference from the terms of any other warranty or any other provision of this agreement.
- 4.3 The rights and remedies of the Company in respect of any breach of the Warranties shall not be affected by completion of the purchase of the Shares, by any investigation made by or on behalf of the Company into the affairs of the Company, by its rescinding or failure to rescind this agreement, by any failure to

exercise or delay in exercising any right or remedy or by any other event or matter whatsoever, except a specific and duly authorised written waiver or release expressly referring to such breach.

- 4.4 The Seller agrees with the Company (for itself and as trustee for its directors, officers and employees) to waive any claim or remedy or right which it may have in respect of any misrepresentation, inaccuracy or omission in or from any information or advice supplied or given by a director, officer or employee of the Company for the purpose of assisting the Seller in giving any warranty, representation, undertaking or covenant, and in entering into this agreement or any agreement or document entered into pursuant to this agreement.
- 4.5 The Seller hereby warrants that:-
  - 4.5.1 The Seller is the sole legal and beneficial owner of the Shares.
  - 4.5.2 The Shares are free from all Encumbrances and no commitment has been given to create an Encumbrance affecting the sale of Shares.
  - 4.5.3 The Seller has not granted to any person any right to require the Company to issue any share capital.
  - 4.5.4 There is no outstanding indebtedness or other liability (actual or contingent) and no outstanding contract, commitment or arrangement between the Company and the Seller or any person Connected with the Seller save for any amounts due to the Seller pursuant to the Compromise Agreement and/or the Loan Agreement.
  - 4.5.5 Neither the Seller, nor any person Connected with the Seller, is at the date of this agreement entitled to a claim of any nature against the Company or any Group Company or has assigned to any person the benefit of a claim against the Company or any Group Company to which the Seller or a person Connected with the Seller would otherwise be entitled.

### 5 Release

The parties agree that this agreement is in full and final settlement of, and they each release and discharge each other from, all and/or any actions, claims, rights, demands and set-offs, whether in this jurisdiction or any other, and whether in law or equity, that they each ever had against the other parties, whether joint or separately, or any of their respective successors in title and assigns arising out of or connected with allegations raised by each other and without prejudice to the generality of the foregoing this includes allegations raised by the Seller against the Continuing Shareholders in respect of unfair prejudice, and any other matter arising out of or in connection with the appointment of the Seller as a director or in connection with his shareholding of the Company (the "Released Claims") save that this clause shall not apply to any claims the parties may have pursuant to the Compromise Agreement and/or the Loan Agreement.

### 6 Restrictions on Seller

**6.1** The Seller covenants with the Company and the Continuing Shareholders that he shall not:

- 6.1.1 at any time during the period of one year beginning with the date of this Agreement, deal with any person who is at the date of this Agreement, or who has been at any time during the period of 24 months immediately preceding that date, a client or customer of the Company or has been contacted by the Company as part of its new business programme, except those persons or organisations specifically referred to in the Schedule; or
- 6.1.2 at any time during the period of one year beginning with the date of this Agreement, canvass, solicit or otherwise seek the custom of any person who is at the Completion Date, or who has been at any time during the period of 24 months immediately preceding that date, a client or customer of the Company or has been contacted by the Company as part of its new business programme, except those persons or organisations specifically referred to in the Schedule; or
- 6.1.3 at any time during the period of one year beginning with the date of this Agreement:
  - (a) offer employment to, enter into a contract for the services of, or attempt to entice away from the Company, any individual who is at the time of the offer or attempt, and was at the date of this Agreement, employed or directly engaged in an executive or managerial position with the Company; or
  - (b) procure or facilitate the making of any such offer or attempt by any other person; or
  - (c) be directly or indirectly engaged as an employee or in an consultative, executive or managerial position with FCA or any subsidiary or holding company of FCA; or
- 6.1.4 at any time after date of this Agreement, use in the course of any business:
  - (a) the name "M3"; or
  - (b) any trade or service mark, business or domain name, design or logo which, at Completion, was or had been used by the Company; or
  - (c) anything which is, in the reasonable opinion of the Company, capable of confusion with such words, mark, name, design or logo.
- 6.2 The covenants in this clause 6 are intended for the benefit of the Company and the Continuing Shareholders and apply to actions carried out by the Seller in any capacity and whether directly or indirectly, on the Seller's own behalf, on behalf of any other person or jointly with any other person.
- 6.3 Each of the covenants in this clause 6 is a separate undertaking and shall be enforceable by the Company separately and independently of its right to enforce any one or more of the other covenants contained in this clause 6. Each of the covenants in this clause 6 is considered fair and reasonable by the parties, but if any restriction is found to be unenforceable, but would be valid if any part of it were deleted or the period or area of application reduced, the restriction shall apply with such modifications as may be necessary to make it valid and enforceable.

6.4 The consideration for the undertakings contained in this clause 6 is included in the Consideration.

## 7 Agreement not to sue

The parties agree not to issue, sue, commence, voluntarily aid in any way, prosecute or cause to be commenced or prosecuted against each other, whether joint or separately, or against the Company, or any of their respective successors in title and assigns, any action, suit or other proceeding concerning any of the Released Claims in this jurisdiction or any other.

#### 8 Further assurance

The parties shall at the expense of the Company use all reasonable endeavours to procure that any necessary third party shall execute such documents and perform such acts as may reasonably be required for the purpose of giving full effect to this agreement.

## 9 Governing law and jurisdiction

- 9.1 This agreement and any dispute or claim arising out of or in connection with it or its subject matter shall be governed by and construed in accordance with the law of England and Wales.
- **9.2** The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this agreement or its subject matter.

## 10 Entire agreement

- 10.1 This agreement, the Compromise Agreement and the Loan Agreement constitute the whole agreement between the parties and supersede all previous agreements between the parties relating to their subject matter.
- 10.2 Each party acknowledges that, in entering into this agreement, it has not relied on, and shall have no right or remedy in respect of, any statement, representation, assurance or warranty (whether made negligently or innocently) other than as expressly set out in this agreement.
- 10.3 Nothing in this clause shall limit or exclude any liability for fraud.

#### 11 Variation

No variation or agreed termination of this agreement shall be effective unless it is in writing and executed by the parties (or their representatives) in the same manner as this agreement.

## 12 Third Party Rights

This agreement is made for the benefit of the parties and is not intended to benefit, or be enforceable by, anyone else.

# 14 Counterparts
