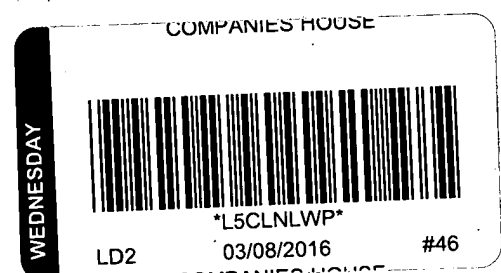



Notes to the Financial Statements

As at 30 November 2015

1. Accounting policies

Basis of preparation

The financial statements have been prepared under the historical cost convention and in accordance with applicable United Kingdom law and accounting standards.

The company has taken advantage of the transitional exemption under FRS 102 35.10 (m) for dormant companies, to retain its accounting policies under UK GAAP for reported assets, liabilities and equity at the date of transition to FRS 102, until there is any change to those balances or the company undertakes any new transactions.

The financial statements are prepared in sterling which is the functional currency of the company and rounded to the nearest £.

Related parties

The company has taken advantage of the exemption in FRS 102.33.1A, not to disclose related party transactions with fellow wholly owned subsidiary undertakings of Time Warner Inc., a company incorporated in the United States of America, which prepares publicly available consolidated financial statements (see note 7).

The company has taken advantage of the exemption in FRS 102.1.12(e) Reduced disclosures for subsidiaries. Key management remuneration has not been disclosed as the company is a member of a group where the parent, Time Warner Inc., prepares publicly available consolidated financial statements and the company is included in the consolidation (see note 7).

Statement of cash flows

The company did not prepare a statement of cash flows as there were no cash based transactions during the period.

2. Profit and loss account

The company has not traded during the year and has made neither a profit nor a loss. No profit and loss account has therefore been prepared.

There were no employees in the current or prior year.

3. Directors' remuneration

The directors received no remuneration from the company for their services to the company during the current or prior year. The directors of the company were paid by fellow group undertakings in the current and prior year.
