1. Accounting policies

Basis of preparation

The financial statements have been prepared under the historical cost convention and in accordance with applicable United Kingdom law and accounting standards.

The company has taken advantage of the transitional exemption under FRS 102 35.10 (m) for dormant companies, to retain its accounting policies under UK GAAP for reported assets, liabilities and equity at the date of transition to FRS 102, until there is any change to those balances or the company undertakes any new transactions.

The financial statements are prepared in sterling which is the functional currency of the company and rounded to the nearest \pounds .
