**UPON** the application of Alan Brian Coleman ("Applicant") dated for a Block Transfer Order in relation to the appointments of Julie Webster ("Respondent")

AND UPON READING the witness statements of the Applicant dated 25/10/17 in support of the Application and the Respondent dated 25/10/17 confirming that she has no objection to the Application

1. The cases listed in Schedule attached to this Order, in so far as they are currently proceedings in a County Court, other District Registries or the Royal Courts of Justice, those proceedings

- be transferred to the High Court, Manchester District Registry, solely for the purpose of hearing the application for the Orders sought below.
- The High Court shall have jurisdiction over each of the insolvency matters in the attached Schedule which have not yet been issued at Court or have not yet been allocated a Court reference.
- 3. In respect of each estate in bankruptcy referred to in Part 1 of the attached Schedule and pursuant to Sections 298 (1) and 303 (2) of the Insolvency Act 1986 ("Act") and r.12,36(2) of the Insolvency (England and Wales) Rules 1986 ("Rules"):
  - a. the Respondent be removed from the office of trustee in bankruptcy of the relevant individual; and
  - b. the Applicant be appointed as trustee in bankruptcy.
- 4. In respect of each administration referred to in Part 2 of the attached Schedule, and pursuant to paragraph 88 of Schedule B1 to the Act and rule 12.36(2) of the Rules the Respondent be removed from the office of Administrator of the relevant company with immediate effect.

Such application shall not affect the transfer of the block transfer cases until further or other order by the court.
- 11. The Applicant shall file a copy of this order with each of the courts listed in the Schedule.

#### 12. The Respondent shall

- a. be at liberty to apply to the Secretary of State for her release from her position as
  - i. Trustee in bankruptcy, pursuant to s.299(b)(ii) of the Act;
  - ii. Voluntary liquidator, pursuant to s.173(2)(b)(ii) of the Act; and
  - iii. Liquidator of a company being wound up by the Court, pursuant to 174(4)(b)(ii) of the Act; and
- b. receive her release as administrator pursuant to Paragraph 98(2)(c) of Schedule B1 to the Act
- 28 days after the relevant notice referred to in paragraph 9 above has been advertised save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 10 of this order for the specific case subject to that application.
- 13. Following the Orders made in paragraphs 1 to 8 above, the proceedings referred to in the Schedule be transferred back to the respective County Courts, District Registries and Royal Courts of Justice, as the case may be.
