Maris Marketing Services Ltd is a private company limited by shares incorporated in England. Its registered office and principal place of business is The Harlequin Building, 65 Southwark Street, London.

The company was dormant (within the meaning of section 480 of the Companies Act 2006) throughout the year ended 31 December 2021. The company has not traded during the year or during the preceding financial year. 2. Basis of preparation of financial statements
