- The applications in so far as they relate to the administrations listed in Rows 43 and 44 of Appendix A to this Order be adjourned generally with liberty to the First Applicant to restore the application in so far as it concerns Row 43 of Appendix A to this Order and to the Second and Third Applicants to restore the application is to far as it concerns Row 44 of Appendix A to this Order
- Unless and until either the earlier of the following (a) the expiry of 18 months following the date of this Order, or (b) further order of the Court or the written consent of the First Successor Practitioner, the Respondent shall preserve
 - all monies and assets of the companies and estates listed in Appendix B to this Order that are in her possession, power, custody or control,
 - the records (whether in paper or electronic form) of the liquidations and estates listed in Appendix B to this Order, including correspondence, time records, proofs, emails sent and received and other related papers, relating to their administration that are in her possession, power, custody or control, and
 - the books, papers, bank documents (including passbooks, cheque books, paying in books, bank statements) and other records of the companies and estates listed in Appendix B to this Order that are in her possession, power, custody or control

- The First Successor Practitioner, Second Successor Practitioner and Third Successor Practitioner shall give notice of their appointment to all creditors of the estates listed in Appendix A (inclusive) to this Order within 28 days of the date of this Order by way of advertisement in the London Gazette
- The Respondent be prohibited from withdrawing any monies whatsoever, whether in respect of outstanding remuneration or otherwise, from the estates of the transferred cases identified in Appendix A (inclusive) to this Order without the permission of the Court or the written consent of the First Successor Practitioner or the Second Successor Practitioner and Third Successor Practitioner as applicable
- The Respondent must by no later than 10am on 23 June 2016 transfer to the First Successor Practitioner or Second Successor Practitioner and Third Successor Practitioner (as applicable) any monies or other assets in her possession, custody, power or control which belong to any of the estates listed in Appendix A (inclusive) to this Order
- 9 The Respondent must permit the First Successor Practitioner, Second Successor Practitioner and Third Successor Practitioner, their employees or agents to attend the Respondent's business premises at Sharma & Co. 257 Hagley Road, Birmingham, West Midlands, B16 9NA (the "Premises")
 - at 10am on 20 June 2016 so that the Respondent can deliver up for safe keeping to the First Successor Practitioner, Second Successor Practitioner and Third Successor Practitioner (as applicable) all of the documents and articles listed in Appendix C to this Order which are available to be handed over for collection in respect of the Companies listed in Appendix A to this Order, including, where available to be handed over at that time (a) time records, (b) physical case files at the Premises, and (c) electronic case files
 - at 9am on Tuesday 28 June 2016 so that the Respondent can deliver up a hard drive (or other electronic storage device) containing the electronic versions of the IPS records in respect of the Companies listed in Appendix A to this Order for safe keeping to the First Successor Practitioner, Second Successor Practitioner and Third Successor Practitioner (as applicable)
- All books and records listed in Appendix C to this Order in respect of the Companies listed in Appendix A to this Order which have been archived by the Respondent shall be delivered up by the Respondent's storage agent to the Premises and be available for collection from the Premises by the First Successor Practitioner, Second Successor Practitioner and Third Successor Practitioner, their employees or agents by 10am on 23 June 2016 For that purpose, the Respondent shall provide written or oral instructions (as required) to the storage agent within sufficient time to enable this to occur

- 13 If any of the documents and articles listed in Appendix C to this Order in respect of the Companies listed in Appendix A to this Order are held by any other person or persons, the Respondent shall inform the First Successor Practitioner, Second Successor Practitioner and Third Successor Practitioner as applicable of their respective names and location by 4pm, 24 June 2016
- Rule 4 49C(3)(b) of the Insolvency Rules 1986 shall not apply as a consequence of this Order
- 15. All creditors of the estates listed in Appendix A to this Order do have permission to apply to the Court, on Notice to the First Successor Practitioner or Second Successor Practitioner and Third Successor Practitioner as applicable within 28 days of the advertisement referred to in paragraph 6 above for the purpose of applying to vary or discharge the Order insofar as it affects the estate or estates of which they are a creditor
- So far as is necessary, the time for service of the Application Notices dated 25 May 2016 and 14 June 2016 upon the Respondent be abridged
- There be no Order as to costs save that the First Successor Practitioner or Second Successor Practitioner and Third Successor Practitioner (as applicable) shall be entitled to charge the costs of this Application as a cost or expense of the estates listed in Appendix A to this Order (each estate to bear an equal share but with no estate having to bear an amount exceeding 10% of the available funds of that estate) only in the event that the First Successor Practitioner or Second Successor Practitioner and Third Successor Practitioner as applicable make additional recoveries of funds exceeding those recovered by the Respondent whilst acting as office holder of the estates
- 18 Permission to Apply
- 19 This order be served by the First Applicant on the other parties
- 20 For the avoidance of doubt paragraphs 8-11 above do not apply to any documents subject to legal privilege of the Respondent or third parties unless or to the extent that

privilege is waived but the Respondent shall retain the same until further order of the court and inform the Applicants of such retention forthwith
