DIVIDENDS SHALL BE PAYABLE ANNUALLY AND NO LATER THAN FOUR MONTHS AFTER THE YEAR END TO WHICH IT RELATES. UPON WINDING UP THE COMPANY, THE SURPLUS ASSETS OF THE COMPANY REMAINING AFTER PAYMENT OF ITS LIABILITIES SHALL BE APPLIED AS FOLLOWS: (I) PAYING TO THE HOLDERS OF THE PREFERENCE SHARES AN AMOUNT EQUAL TO THE NOMINAL VALUE OF SUCH SHARES, TOGETHER WITH A SUM EQUAL TO ALL ARREARS OR ACCRUAL OF DIVIDENDS; (II) THE REMAINING ASSETS SHALL BELONG AND BE DISTRIBUTED TO THE ORDINARY SHAREHOLDERS.
