  - 4.1.2.1 An explanation of the effect of this Order;
  - 4.1.2.2 In the case of liquidations, where liquidation committees of creditors' committees have been appointed, an explanation that, to the extent that any information which would otherwise be required to be provided has not already been provided as part of the report, it is open to that committee to require the Applicant to provide an account of the administration of the estate, including a summary of receipts and payments and a statement that they have reconciled the accounts;
