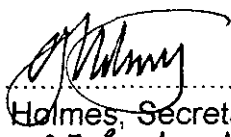
**Profit and Loss Account for the Accounting Reference Period ended

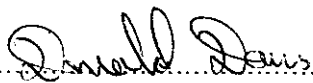
