### Review of the Year

### Introduction

This is a brief report of what we have been doing in the last year. We have sought to serve the church of Jesus Christ by providing Bible teaching and training in the same. We strive to be true to the verse from 2 Corinthians 4:5 "For we do not preach ourselves, but Jesus Christ as Lord, and ourselves as your servants for Jesus' sake." which we chose to use as our slogan back in September 2000.

### **Positives**

The main focus of our work has remained as the provision of good Bible teaching and preaching. There have been many opportunities for Bob's preaching and teaching this year. But by far the major change in Bob's ministry has been the introduction of his work with Pastors in Kenya. He was invited by Bishop Henry Partridge of Meru diocese, Kenya to help with training at an African Pastors' Fellowship conference. He then travelled around Kenya with Ralph and Jayne Hanger of APF seeing their projects and helping on two other training courses at Kisumu and Nairobi. The trip was very successful but the last week was very frustrating as the training was severely curtailed due to the slums being unsafe because of political unrest. He hopes to return again in August 2003.

Colin continues to support churches who are in need of youth and children's sessional support and/or leadership. He has worked with St. Mary & St. Ambrose Church, Edgbaston; St. Christopher, Frankley & St. Alphege, Solihull. His continues to preach and lead services at his own Church of St. Boniface, Quinton.

The Summer saw us away at Lancaster CYFA Venture, Alton Castle Falcon Camp, & Halls Green 3 Falcon Camp.

Lancaster was a great success. The change of site was dropped on us at very late notice when the Bentham School Site was sold and the new owners pulled out of the agreement. For the first time in many years, we had a lot of rain. We were grateful for a site with plenty of indoor accommodation — something which we did not have at Bentham. We will continue to look for a new site as Lancaster, good as it is, is not suited to our Venture. Several members professed faith in Christ for the first time with others making a recommitment. Alton Castle FC was also good with some members there making professions of faith. This was also a new site and despite the thrill of being in a real castle, the leaders felt that there were too many nooks and crannies for this to be a permanent move.

After Lancaster, Colin went on to lead Halls Green 3 Falcon Camp. This was a success despite running with a small team. He plans to build on the core team and expand

leadership for 2003.

### **Frustrations**

We have still found little time to develop the training games 'Seeds' and 'Project-tiles'. Colin continues to be the mainstay of administration support but there is not enough funding or work available to justify his position full-time. It is planned that his hours will be reduced to 20 hours/week from May 1st 2003.

# **Future Plans**

### **Short Term**

We will continue 'Word' based ministries at St. Mark's, St. Mary & St. Ambrose, St. Boniface, and where opportunities arise.

We will continue trying to achieve progress on a web-based ideas and articles system.

We will aim to develop 'Seeds' as a suite of church training tools.

We will try to get 'Project Tiles' to work as a game.

### Medium term

We will seek to develop Bob's work with Kenyan Pastors which will include a return visit in August 2003.

### Long term

We hope to continue to grow Bob's teaching ministry and serve the church through training and encouragement, growing the work as funds allow. We also seek God's will for Colin as he looks to the future and the ministry God has for him.
