

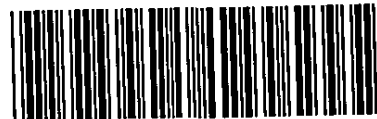


The Company is, for taxation purposes, a "close" Company
